HOUSE BILL NO. 424

1 AN ACT MAKING AN APPROPRIATION TO THE CITY OF COLUMBIA AND
 2 MARION COUNTY TO ASSIST THE CITY IN PAYING COSTS ASSOCIATED WITH
 3 MAKING IMPROVEMENTS TO CITY ROADS, STREETS AND BRIDGES, AND TO
 4 ASSIST THE COUNTY IN PAYING COSTS ASSOCIATED WITH MAKING
 5 IMPROVEMENTS TO THE COLUMBIA-MARION COUNTY AIRPORT AND IN PAYING
 6 COSTS ASSOCIATED WITH MAKING IMPROVEMENTS TO COUNTY ROADS, STREETS
 7 AND BRIDGES FOR THE FISCAL YEAR 2019.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

9 **SECTION 1.** The following sum, or so much of it as may be
 10 necessary, is appropriated out of any money in the State General
 11 Fund not otherwise appropriated, to the City of Columbia,
 12 Mississippi, and Marion County, Mississippi, to assist the city
 13 and the county with the projects described in Section 2 of this
 14 act for the fiscal year beginning July 1, 2018, and ending June
 15 30, 2019.....\$ 9,000,000.00.

16 **SECTION 2.** The monies appropriated by Section 1 of this act
 17 shall be distributed as follows:

18 (a) To the City of Columbia, Mississippi, to assist the
 19 city in paying costs associated with the repair, rehabilitation,



20 resurfacing, construction and reconstruction of city roads,
21 streets and bridges.....\$ 2,000,000.00.

22 (b) To Marion County, Mississippi, to assist the county
23 in paying costs associated with planning, design, construction,
24 repair, rehabilitation, renovation, replacement, furnishing,
25 equipping, expansion of and additions and other improvements to
26 infrastructure, buildings, facilities and other property at the
27 Columbia-Marion County Airport in Marion County.....
28\$ 2,000,000.00.

29 (c) To Marion County, Mississippi, to assist the county
30 in paying costs associated with the repair, rehabilitation,
31 resurfacing, construction and reconstruction of county roads,
32 streets and bridges.....\$ 5,000,000.00.

33 **SECTION 3.** The money appropriated by this act shall be paid
34 by the State Treasurer out of any money in the State General Fund
35 not otherwise appropriated, upon warrants issued by the State
36 Fiscal Officer; and the State Fiscal Officer shall issue his
37 warrants upon requisitions signed by the proper person, officer or
38 officers in the manner provided by law.

39 **SECTION 4.** This act shall take effect and be in force from
40 and after July 1, 2018.
