HOUSE BILL NO. 442

AN ACT TO REQUIRE SCHOOL DISTRICTS ACCREDITED AT ONE OF THE 1 2 THREE LOWEST ACCOUNTABILITY RATINGS, AS DEFINED BY THE STATE BOARD 3 OF EDUCATION, TO ADOPT CERTAIN POLICIES AND PROCEDURES REGARDING DAILY CURRICULUM, WEEKLY HOMEWORK ASSIGNMENTS, PARENTAL 4 5 INVOLVEMENT, DRESS CODES, SCHOOL HOLIDAYS, PARENT-TEACHER 6 CONFERENCES AND A SCHOOL SYLLABUS; TO REQUIRE ALTERNATIVE SCHOOLS 7 IN THOSE DISTRICTS TO ADHERE TO THE SAME POLICIES AND PROCEDURES; 8 TO REQUIRE ALL LOCAL SCHOOL DISTRICTS TO IMPLEMENT A VIDEO 9 STREAMING PROGRAM IN CONJUNCTION WITH THE UNITED STATES DEPARTMENT OF LABOR TO AID IN THE DEVELOPMENT OF AN ALTERNATIVE CAREER-TRACK 10 11 CURRICULUM BASED UPON OCCUPATIONAL PROJECTIONS IN THE STATE AND 12 COUNTRY FOR THE NEXT FIVE YEARS; TO REQUIRE SCHOOL DISTRICTS TO 13 ASSIST STUDENTS IN ACCESSING INFORMATION FROM THE DEPARTMENT OF LABOR WHICH WILL ENABLE THE STUDENTS TO MAKE CAREER CHOICES; TO 14 REQUIRE A SCHOOL DISTRICT'S ALTERNATIVE CAREER-TRACK CURRICULUM TO 15 SATISFY ITS GRADUATION REQUIREMENTS AND LEAD TO THE AWARDING OF A 16 17 STANDARD HIGH SCHOOL DIPLOMA; AND FOR RELATED PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: **SECTION 1.** (1) The school board of each school district having an accountability rating at one (1) of the three (3) lowest levels, as defined by the State Board of Education, shall adopt policies and procedures regarding the daily curriculum in schools, weekly homework assignments, parental involvement, dress codes, school holidays, parent-teacher conferences and a school syllabus. 25 The policies and procedures must include, but not necessarily be 26 limited to, the following:

27 (a) Every child must be assigned daily homework28 assignments;

(b) Every child must be taught to write in proper
manuscript and cursive lettering, which must be reinforced through
weekend homework assignments at every grade level;

32 (c) Every child must be assigned a daily reading33 assignment;

34 (d) Every child must be assigned a daily written
35 assignment to accompany the daily reading assignment in order to
36 assess the reading comprehension level of the child;

(e) Every child must be assigned a minimum of five (5) words per week in each subject area to learn to spell, define and use in a sentence, which must be used to assess the child's retention of the assignment;

(f) Every child must be assigned a minimum of one (1) book to read per subject each month and must write a short report on the subject matter of the book, which report must be used to assess the child's learning ability. Children in primary grades may be allowed to draw pictures, elaborate orally or use any other alternative method to tell about their books;

50 for an athletic event, chaperoning a school sponsored event, 51 serving in the Parent Teacher Association, or serving as a mentor, 52 resource officer or tutor;

53 (h) Every teacher shall dress in a professional manner, 54 which does not include wearing blue jeans, denim jeans or tee 55 shirts;

56 (i) Every child must be required to wear a school 57 uniform;

(j) The school districts shall provide for only the
following school holidays: Labor Day, Thanksgiving, Christmas,
New Year's, Dr. Martin Luther King, Jr., Spring Break and Good
Friday holidays. Permanent early release days are prohibited;

62 (k) Staff development training may not be held during a 63 regular school day; however, staff development training may be 64 offered after the regular school day has been completed. The 65 staff development training must be relevant to the teaching 66 experience and beneficial to the teacher, student and district as 67 a whole;

68 (1) Parent-teacher conferences must be held at the
69 middle of each nine-week term with the parent and a child who has
70 not mastered his or her coursework for the mid-term or who has
71 demonstrated bad citizenship;

(m) The school district shall provide a syllabus for
each nine (9) weeks with the homework assignments posted for each
subject. The syllabus must contain an agreement that the parent

H. B. No. 442 18/HR26/R1150 PAGE 3 (DJ\KW) or guardian is required to sign stating that the parent understands the child has daily homework assignments and that the parent has received a document outlining the child's work assignments and due dates of the assignments; and

(n) The school district shall post the syllabus on the school district website, if available. If a student loses his or her syllabus, the school district may charge a fee of not more than Twenty-five Cents (25¢) per individual sheet to copy and replace the document.

84 (2)Alternative school programs in school districts having 85 an accreditation rating at one (1) of the three (3) lowest levels, as defined by the State Board of Education, shall adhere to the 86 policies required under subsection (1) of this section. 87 Students attending an alternative school must attend school for no less 88 89 than eight (8) hours per day and must attend school on Saturday 90 for no less than eight (8) hours per day. At alternative schools, Saturday must be known as "Attitude Adjustment Day." Each 91 92 Saturday, the school districts shall arrange for retired military, 93 first responders, volunteer mentors, ministers, parents and any other community volunteers to attend school with the alternative 94 95 school students and to share their skills and knowledge with the 96 students, encouraging them to become better students and citizens. 97 In addition, the school district may authorize students to 98 participate in community service programs on Saturdays to help

99 build character and concern for their own school, family, 100 neighborhood and community.

101 Each school district shall design and **SECTION 2.** (1) 102 implement a video streaming program in conjunction with the United 103 States Department of Labor to aid in the development of the school 104 district's curriculum. Using state and national occupational projections available through the Department of Labor, the school 105 106 district shall develop an alternative career-track curriculum that 107 prepares students for direct entry into the workforce or 108 post-secondary education and training in the five (5) occupations 109 projected to be the fastest growing in the State of Mississippi, 110 and in the twenty (20) occupations projected to be the fastest 111 growing in the country, over the next succeeding five (5) years. The district shall provide students with access to the Department 112 113 of Labor, via video streaming means, and shall assist students in 114 gathering relevant information from the Department of Labor which 115 will enable the students to make informed, educated career choices 116 and to select the curriculum that will begin the students on a path toward a meaningful and rewarding occupation. 117

118 (2) An alternative career-track curriculum developed and 119 implemented in a school district under subsection (1) of this 120 section must be designed to enable students to meet all necessary 121 requirements for graduation and to be awarded a standard high 122 school diploma upon graduation from a high school within that 123 district.
