HOUSE BILL NO. 465

AN ACT TO REQUIRE ALL AGENCIES, DEPARTMENTS, INSTITUTIONS AND 2 POLITICAL SUBDIVISIONS OF THE STATE THAT PROVIDE PROGRAMS OR 3 SERVICES TO CHILDREN IN THIS STATE TO ANNUALLY CREATE AN ITEMIZED LIST OF THE PROGRAMS AND SERVICES PROVIDED TO CHILDREN; TO REQUIRE 5 THAT THE LIST CONTAIN A DESCRIPTION OF THE PROGRAMS AND SERVICES, 6 A RESOURCE MAPPING OF ALL FEDERAL AND STATE FUNDS RECEIVED, COSTS 7 ASSOCIATED WITH THE PROGRAMS AND SERVICES, THE NUMBER OF CHILDREN 8 SERVED BY THE PROGRAMS AND SERVICES, AND ANY PERFORMANCE MEASURES 9 USED TO ASSESS THE PROGRAMS AND SERVICES; TO PROVIDE THAT THE ITEMIZED LISTS OF PROGRAMS AND SERVICES SHALL BE PROVIDED TO THE 10 11 JOHN C. STENNIS INSTITUTE OF GOVERNMENT AT MISSISSIPPI STATE 12 UNIVERSITY NOT LATER THAN SEPTEMBER 1 OF EACH YEAR; TO PROVIDE 13 THAT THE STENNIS INSTITUTE SHALL COMPILE THE INFORMATION IN THOSE LISTS INTO ONE DOCUMENT, AND SHALL MAKE THE COMPILED INFORMATION 14 AVAILABLE TO CERTAIN COMMITTEES OF THE LEGISLATURE BY DECEMBER 1 15 16 OF EACH YEAR; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 17 18 SECTION 1. (1) All agencies, departments, institutions and 19 political subdivisions of the state that provide programs or 20 services to children in this state shall annually create an itemized list of the programs and services provided by that 21 22 agency, department, institution or political subdivision. The 23 itemized list shall provide the following information: 24 A description of the programs and services, 25 categorized by program, target population and geographical region; H. B. - 33 (e) The number of children served by the programs and 34 services.
- The agencies, departments, institutions and political 35 (2) 36 subdivisions shall provide the itemized lists of the programs and services required by subsection (1) of this section to the John C. 37 Stennis Institute of Government at Mississippi State University 38 39 (Stennis Institute) not later than September 1 of each year. The 40 Stennis Institute shall compile the information in those lists 41 into one (1) document, organized both by programs and services and by the agencies, departments, institutions and political 42 43 subdivisions providing the programs and services. The Stennis 44 Institute shall make the compiled information available to the 45 Chairperson and Vice Chairperson of the Appropriations, Education
- 46 and Public Health and Human Services Committees of the Mississippi
- 47 House of Representatives, and the Appropriations, Education and
- 48 Public Health and Welfare Committees of the Mississippi Senate by
- 49 December 1 of each year.

50 **SECTION 2.** This act shall take effect and be in force from 51 and after July 1, 2018.
