## HOUSE BILL NO. 770

- AN ACT TO AMEND SECTION 73-11-51, MISSISSIPPI CODE OF 1972,
  TO DIRECT THE STATE BOARD OF FUNERAL SERVICE TO ISSUE A LICENSE
  FOR THE PRACTICE OF FUNERAL DIRECTING TO PERSONS WHO MEET CERTAIN
  CRITERIA AND WHO MAKE APPLICATION WITHIN A THIRTY-DAY PERIOD; AND
  FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 73-11-51, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 73-11-51. (1) No person shall engage in the business or
- 10 practice of funeral service, including embalming, and/or funeral
- 11 directing or hold himself out as transacting or practicing or
- 12 being entitled to transact or practice funeral service, including
- 13 embalming, and/or funeral directing in this state unless duly
- 14 licensed under the provisions of this chapter.
- 15 (2) The board is authorized and empowered to examine
- 16 applicants for licenses for the practice of funeral service and
- 17 funeral directing and shall issue the proper license to those
- 18 persons who successfully pass the applicable examination and
- 19 otherwise comply with the provisions of this chapter.

- 43 from an institution accredited by the American Board of Funeral

- 45 States Department of Education for funeral service education;
- 46 (d) Has served as a resident trainee for not less than
- 47 twelve (12) months, either before or after graduation from an
- 48 accredited institution mentioned above, under the supervision of a
- 49 person licensed for the practice of funeral service in this state
- 50 and in an establishment licensed in this state;
- (e) Has successfully passed the National Conference of
- 52 Funeral Examiners examination and/or such other examination as
- 53 approved by the board; and
- (f) Is of good moral character.
- 55 (5) All applications for examination and license for the
- 56 practice of funeral service or funeral directing shall be upon
- 57 forms furnished by the board and shall be accompanied by an
- 58 examination fee, a licensing fee and a nonrefundable application
- 59 fee in amounts fixed by the board in accordance with Section
- 60 73-11-56. The fee for an initial license, however, may be
- 61 prorated in proportion to the period of time from the date of
- 62 issuance to the date of biennial license renewal prescribed in

- 64 shall be filed with the board office at least sixty (60) days
- 65 before the date of examination. A candidate shall be deemed to
- 66 have abandoned the application for examination if he does not
- 67 appear on the scheduled date of examination unless such failure to
- 68 appear has been approved by the board.

70	must be engaged in at a licensed funeral establishment, at least
71	one (1) of which is listed as the licensee's place of business;
72	and no person, partnership, corporation, association or other
73	organization shall open or maintain a funeral establishment at
74	which to engage in or conduct or hold himself or itself out as
75	engaging in the practice of funeral service or funeral directing
76	until such establishment has complied with the licensing
77	requirements of this chapter. A license for the practice of
78	funeral service or funeral directing shall be used only at
79	licensed funeral establishments; however, this provision shall not
80	prevent a person licensed for the practice of funeral service or
81	funeral directing from conducting a funeral service at a church, a
82	residence, public hall, lodge room or cemetery chapel, if such
83	person maintains a fixed licensed funeral establishment of his own
84	or is in the employ of or an agent of a licensed funeral

(7) Any person holding a valid, unrevoked and unexpired nonreciprocal license in another state or territory having requirements greater than or equal to those of this state as determined by the board may apply for a license to practice in this state by filing with the board a certified statement from the secretary of the licensing board of the state or territory in which the applicant holds his license certifying to his qualifications and good standing with that board. 94 also successfully pass a written and/or oral examination on the 95 Mississippi Funeral Service licensing law and rules and 96 regulations as prepared or approved by the board, and must pay a nonrefundable application fee set by the board. If the board 97 98 finds that the applicant has fulfilled aforesaid requirements and 99 has fulfilled substantially similar requirements of those required 100 for a Mississippi licensee, the board shall grant such license upon receipt of a fee in an amount equal to the renewal fee set by 101 102 the board for a license for the practice of funeral service or 103 funeral directing, as the case may be, in this state. The board 104 may issue a temporary funeral service or funeral directing work 105 permit before a license is granted, before the next regular 106 meeting of the board, if the applicant for a reciprocal license 107 has complied with all requirements, rules and regulations of the 108 The temporary permit will expire at the next regular 109 meeting of the board. The issuance of a license or temporary 110 permit by reciprocity to a military-trained applicant or military spouse shall be subject to the provisions of Section 73-50-1. 111 112 (8) Except as provided in Section 33-1-39, any person (a) 113 holding a license for the practice of funeral service or funeral 114 directing may have the same renewed for a period of two (2) years 115 by making and filing with the board an application on or before 116 the due date. Payment of the renewal fee shall be in an amount 117 set by the board in accordance with Section 73-11-56. The board

shall mail the notice of renewal and the due date for the payment

- 119 of the renewal fee to the last-known address of each licensee at
- 120 least thirty (30) days before that date. It is the responsibility
- 121 of the licensee to notify the board in writing of any change of
- 122 address. An application will be considered late if the
- 123 application and proper fees are not in the board's office or
- 124 postmarked by the due date. Failure of a license holder to
- 125 receive the notice of renewal shall not exempt or excuse a license
- 126 holder from the requirement of renewing the license on or before
- 127 the license expiration date.
- 128 (b) If the renewal fee is not paid on or postmarked by
- 129 the due date, the license of such person shall by operation of law
- 130 automatically expire and become void without further action of the
- 131 The board may reinstate such license if application for
- 132 licensure is made within a period of five (5) years, upon payment
- 133 of the renewal fee for the current year, all renewal fees in
- arrears, and a reinstatement fee. After a period of five (5) 134
- 135 years, the licensee must make application, pay the current renewal
- fee, all fees in arrears, and pass a written and/or oral 136
- 137 examination as prepared or approved by the board.
- 138 No license shall be assignable or valid for any person (9)
- 139 other than the original licensee.
- The board may, in its discretion, if there is a major 140
- 141 disaster or emergency where human death is likely to occur,
- temporarily authorize the practice of funeral directing and 142
- funeral service by persons licensed to practice in another state 143

- 146 Any funeral service technology or mortuary science program accredited by the American Board of Funeral Service 147 148 Education in the State of Mississippi, as well as students 149 enrolled in such a program, shall be exempt from licensing under 150 this chapter when embalming or otherwise preparing a deceased 151 human body for disposition as part of a student practicum 152 experience, when the student is directly supervised by an 153 instructor or preceptor who holds a current funeral service 154 license. This exemption shall apply to practicum experiences 155 performed at an accredited institution of funeral service 156 technology or mortuary science program or at a duly licensed 157 funeral establishment or commercial mortuary service. Nothing in 158 this subsection shall be construed to allow any funeral service 159 technology or mortuary science program, or those students enrolled 160 in such a program, to engage in practicum experiences for 161 remuneration.
- 162 Notwithstanding any provision of this chapter, the (12)163 board shall issue a license for the practice of funeral directing 164 to any person who (a) is fifty (50) years of age or older, (b) has 165 experience as an employee at a licensed funeral establishment in 166 Mississippi for not less than five (5) consecutive years 167 immediately preceding the date of the application for the license, (c) is presently employed at a licensed funeral establishment in 168

169	Mississippi, (d) makes application to the board for the license
170	during the period from July 1, 2018, through July 31, 2018, and
171	(e) pays all applicable fees for application and licensure. The
172	board shall furnish persons seeking licensure under this
173	subsection an application form upon request. The applicant's
174	previous experience and current employment at a licensed funeral
175	establishment in Mississippi must be documented in writing by the
176	owner, management or licensee in charge of the funeral
177	establishment and included with the application to the board.
