HOUSE BILL NO. 1150 (As Sent to Governor)

AN ACT TO DESIGNATE A PORTION OF HIGHWAY 27 IN COPIAH COUNTY 2 AS "LARRY GRANTHAM MEMORIAL HIGHWAY"; TO DESIGNATE A PORTION OF 3 HIGHWAY 63 IN WAYNE COUNTY AS "WILLIAM CLEO PITTS MEMORIAL HIGHWAY"; TO DESIGNATE A BRIDGE ON ADAMS STREET IN THE CITY OF FULTON IN ITAWAMBA COUNTY AS "LELAND TAYLOR MEMORIAL BRIDGE"; TO 5 6 DESIGNATE AN OVERPASS BRIDGE ON MISSISSIPPI HIGHWAY 309 IN MARSHALL COUNTY AS "JIM TUTTLE MEMORIAL OVERPASS"; TO DESIGNATE 7 UNITED STATES HIGHWAY 82 IN WASHINGTON COUNTY AS "DELTA RHYTHM & 8 BAYOUS HIGHWAY"; TO DESIGNATE A CERTAIN SEGMENT OF MISSISSIPPI 9 10 HIGHWAY 15 IN NEWTON COUNTY, MISSISSIPPI, AS THE "RAYMOND COMANS MEMORIAL HIGHWAY"; TO DESIGNATE A CERTAIN SEGMENT OF MISSISSIPPI 11 12 HIGHWAY 15 IN OKTIBBEHA COUNTY, MISSISSIPPI, AS THE "NICKY LEWIS MEMORIAL HIGHWAY"; AND FOR RELATED PURPOSES. 13

- 14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 15 **SECTION 1.** (1) That portion of United States Highway 27 in
- 16 Copiah County, Mississippi, beginning at its intersection with
- 17 United States Highway 51 and extending southeasterly to its
- 18 intersection with Old Highway 27 #2 is designated and shall be
- 19 known as "Larry Grantham Memorial Highway."
- 20 (2) The Mississippi Department of Transportation shall erect
- 21 and maintain appropriate signs along and approaching the portion
- 22 of highway described in subsection (1) of this section.

- 23 **SECTION 2.** (1) That portion of Mississippi Highway 63 in
- 24 Wayne County, Mississippi, beginning at its intersection with Red
- 25 Brown Drive and extending southerly for one (1) mile, is
- 26 designated and shall be known as "William Cleo Pitts Memorial
- 27 Highway."
- 28 (2) The Mississippi Department of Transportation shall erect
- 29 and maintain appropriate signs along and approaching the portion
- 30 of highway described in subsection (1) of this section.
- 31 **SECTION 3.** (1) That bridge on Adams Street that spans
- 32 Interstate 22 in Itawamba County, Mississippi, in the City of
- 33 Fulton, is designated and shall be known as "Leland Taylor
- 34 Memorial Bridge."
- 35 (2) The Mississippi Department of Transportation shall erect
- 36 and maintain an appropriate plaque at each end of the bridge, and
- 37 suitable markers along and approaching the bridge, described in
- 38 subsection (1) of this section.
- 39 **SECTION 4.** (1) That overpass bridge on Mississippi Highway
- 40 309 that spans Interstate 269 in Marshall County, Mississippi, is
- 41 designated and shall be known as "Jim Tuttle Memorial Overpass."
- 42 (2) The Mississippi Department of Transportation shall erect
- 43 and maintain an appropriate plaque at each end of the overpass
- 44 bridge, and suitable markers along and approaching the overpass
- 45 bridge, described in subsection (1) of this section.
- SECTION 5. (1) United States Highway 82 in Washington
- 47 County, Mississippi, is designated the "Delta Rhythm & Bayous

- 48 Highway" as part of the corridor that connects to the "Delta
- 49 Rhythm & Bayous Highway" in Arkansas.
- 50 (2) The Mississippi Department of Transportation shall erect
- 51 and maintain appropriate signs along and approaching the portion
- 52 of highway described in subsection (1) of this section.
- 53 **SECTION 6.** (1) The segment of Mississippi Highway 15 in
- 54 Newton County, Mississippi, beginning at its intersection of
- 55 Savell Road and extending north to its intersection with Stratton
- 56 Road, is designated as the "Raymond Comans Memorial Highway."
- 57 (2) The Mississippi Department of Transportation shall erect
- 58 and maintain appropriate signs along and approaching the segment
- 59 of highway described in subsection (1) of this section.
- 60 **SECTION 7.** (1) The segment of Mississippi Highway 15 in
- 61 Oktibbeha County, Mississippi, beginning at its intersection of
- 62 County Line Road and extending north to its intersection with
- 63 Hatcher Road, is designated as the "Nicky Lewis Memorial Highway."
- 64 (2) The Mississippi Department of Transportation shall erect
- 65 and maintain appropriate signs along and approaching the segment
- of highway described in subsection (1) of this section.
- 67 **SECTION 8.** This act shall take effect and be in force from
- 68 and after July 1, 2018.
