HOUSE BILL NO. 1266

AN ACT TO AMEND SECTION 37-106-55, MISSISSIPPI CODE OF 1972,
TO AUTHORIZE THE CONTINUATION OF THE CRITICAL NEEDS TEACHER
FORGIVABLE LOAN PROGRAM AS A FOUR-YEAR REPAYMENT PROGRAM AND TO
ALLOW APPLICANTS TO RESIDE OR BE EMPLOYED IN ANY GEOGRAPHICAL AREA
OF THE STATE UNDER A SEVEN-YEAR REPAYMENT PROGRAM; AND FOR RELATED PURPOSES.

- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 8 SECTION 1. Section 37-106-55, Mississippi Code of 1972, is
- 9 amended as follows:
- 10 37-106-55. (1) There is established the "Critical Needs
- 11 Teacher Forgivable Loan Program," the purpose of which is to
- 12 attract qualified teachers to those geographical areas of the
- 13 state and those subject areas of the curriculum where there exists
- 14 a critical shortage of teachers by awarding forgivable loans to
- 15 persons declaring an intention to serve in the teaching field who
- 16 actually render service to the state while possessing an
- 17 appropriate teaching license.
- 18 (2) * * * The Critical Needs Teacher Scholarship

- 19 Program * * * is hereby continued for applicants after the * * *
- 20 2017-2018 academic year, and in subsequent years * * * subject to
