HOUSE BILL NO. 1267

AN ACT TO AMEND SECTION 37-5-7, MISSISSIPPI CODE OF 1972, TO PROVIDE FOR THE MODIFIED PROCESS OF ELECTING AND APPOINTING OF COUNTY SCHOOL BOARD MEMBERS FOR GEORGE COUNTY AT THE 2019 STATEWIDE GENERAL ELECTION; TO PROVIDE THAT THREE MEMBERS OF THE 5 BOARD SHALL BE ELECTED FROM THREE NEW SINGLE MEMBER DISTRICTS APPORTIONED IN ACCORDANCE TO THE POPULATION OF THE COUNTY; TO 7 REQUIRE THE COUNTY BOARD OF SUPERVISORS AND THE LOCAL GOVERNING 8 AUTHORITIES OF MUNICIPALITIES WHEREIN THE SEATS OF GOVERNMENT IS 9 LOCATED TO APPOINT THE REMAINING TWO MEMBERS FROM THE COUNTY AT 10 LARGE; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 12 **SECTION 1.** Section 37-5-7, Mississippi Code of 1972, is 13 amended as follows: 37-5-7. (1) On the first Tuesday after the first Monday in 14 15 May, 1954, an election shall be held in each county in this state 16 in the same manner as general state and county elections are held 17 and conducted, which election shall be held for the purpose of electing the county boards of education established under the 18 provisions of this chapter. At such election, the members of the 19 20 said board from Supervisors Districts * * * 1 and * * * 2 shall be elected for the term expiring on the first Monday of January, 21 1957; members of the board from Supervisors Districts * * * 3 22

- 23 and * * * 4 shall be elected for a term expiring on the first
- 24 Monday of January, 1959; and the member of the board from
- 25 Supervisors District * * * 5 shall be elected for a term expiring
- 26 on the first Monday of January, 1955. Except as otherwise
- 27 provided in subsection (2), all subsequent members of the board
- 28 shall be elected for a term of six (6) years at the regular
- 29 general election held on the first Monday in November next
- 30 preceding the expiration of the term of office of the respective
- 31 member or members of such board. All members of the county board
- 32 of education as herein constituted, shall take office on the first
- 33 Monday of January following the date of their election.
- 34 (2) On the first Tuesday after the first Monday in November,
- 35 in any year in which any county shall elect to utilize the
- 36 authority contained in Section 37-5-1(2), an election shall be
- 37 held in each such county in this state for the purpose of electing
- 38 the county boards of education in such counties. At said election
- 39 the members of the said county board of education from
- 40 Districts * * * 1 and * * * 2 shall be elected for a term of four
- 41 (4) years, the members from Districts * * * 3 and * * * 4 shall be
- 42 elected for a term of six (6) years, and the member from
- 43 District * * * 5 shall be elected for a term of two (2) years.
- 44 Thereafter, members shall be elected at general elections as
- 45 vacancies occur for terms of six (6) years each. All members of
- 46 the county board of education shall take office on the first
- 47 Monday of January following the date of their election.

48	(3) (a) Current members of the Board of Trustees of the
49	Greenwood Public School District serving on November 1, 2017,
50	shall continue in office as the new County Board of Education of
51	the Greenwood-Leflore School District until their successors are
52	elected as follows:
53	(i) The two (2) appointed board members of the
54	Greenwood Public School District whose terms are nearest to
55	expiration shall expire on January 1, 2019, and thereafter become
56	permanently elected positions to be filled by persons elected as
57	board members from Supervisors Districts 2 and 3 in a November
58	2018 election held for that purpose, in the manner prescribed in
59	Section 37-7-203, and the newly elected members will take office
60	on January 1, 2019, for a term of four (4) years;
61	(ii) The final two (2) appointed board members of
62	the Greenwood Public School District whose terms are the farthest
63	removed from expiration shall expire on January 1, 2020, and
64	thereafter become permanently elected positions to be filled by
65	persons elected as board members from Supervisors Districts 4 and
66	5 in a November 2019 election held for that purpose, in the manner
67	prescribed in Section 37-7-203, and the newly elected members will
68	take office on January 1, 2020, for a term of four (4) years; and
69	(iii) One (1) appointed board member of the
70	Greenwood Public School District whose term is next nearest to
71	expiration shall expire on January 1, 2021, and thereafter become
72	a permanently elected position to be filled by a person elected as

- 74 election held for that purpose, in the manner prescribed in
- 75 Section 37-7-203, and the newly elected members will take office
- 76 on January 1, 2021, for a term of four (4) years.
- 77 (b) All subsequent members shall be elected for a term
- 78 of four (4) years at the regular general election held on the
- 79 first Monday in November next preceding the expiration of the term
- 80 of office of the respective members, and shall take office on
- 81 January 1 next succeeding the election.
- 82 (4) On the first Tuesday after the first Monday in November
- 83 2017, an election shall be held in Holmes County for the purpose
- 84 of electing the county board of education in the new Holmes County
- 85 Consolidated School District. At the election, the members of the
- 86 said county board of education shall be elected from single member
- 87 board of education districts, which shall be consistent with the
- 88 supervisors district lines in the county, and shall be elected for
- 89 an initial term of six (6) years. Subsequent elections for the
- 90 Holmes County Board of Education shall be held on the first
- 91 Tuesday after the first Monday in November 2023 and every four (4)
- 92 years thereafter at the same time and manner as other general
- 93 elections are held, and the member shall be elected for a term of
- 94 four (4) years. All members of the county board of education in
- 95 the new Holmes County Consolidated School District shall take
- 96 office on the first Monday of January following the date of their
- 97 election.

98	(5) On the first Tuesday after the first Monday in November
99	2023, an election shall be held in Chickasaw County for the
100	purpose of electing the county board of education in the new
101	Chickasaw County School District. The board of supervisors shall
102	declare and designate posts for each member of the new board. At
103	said election, the members of the said county board of education
104	from Posts One and Two shall be elected for a term of four (4)
105	years, the members from Posts Three and Four shall be elected for
106	a term of three (3) years and the member from Post Five shall be
107	elected for a term of two (2) years. Thereafter, members shall be
108	elected at general elections as vacancies occur for terms of four
109	(4) years each. All members of the county board of education in
110	the new Chickasaw County School District shall take office on the
111	first Monday of January following the date of their election.
112	(6) (a) On the first Tuesday after the first Monday in
113	November 2019, and every four (4) years thereafter, an election
114	shall be held at the same time and manner as other statewide
115	general elections are held in George County for the purpose of
116	electing members of the county board of education in the George
117	County School District. The board of supervisors for the county
118	designated in this subsection shall be responsible for
119	apportioning the county into three (3) single member board of
120	education election districts, which shall be consistent with the
121	apportioned population of the county. The board of supervisors of
122	the county shall thereafter publish the same in some newspaper of

123	general circulation in the county for at least three (3)
124	consecutive weeks and having given notice of publication and
125	recording the same upon the minutes of the school board, the new
126	election district lines will thereafter be effective for the
127	November 2019 general election.
128	(b) After the election results for the office of school
129	board members have been certified by the Secretary of State, the
130	remaining two (2) members of the county school board shall be
131	appointed from the county at large as follows:
132	(i) One (1) member shall be appointed from the
133	county at large by the board of supervisors; and
134	(ii) One (1) member shall be appointed from the
135	county at large by the local governing authority of the
136	municipality wherein the seat of government is located subject to
137	the provisions of this subsection.
138	(c) School board members elected at the general
139	election and those appointed by the appropriate governing
140	authorities upon the certification of election results shall be
141	elected and appointed for a term of four (4) years, and shall take
142	office on the first Monday of January following the date of their
143	election or appointment.
144	SECTION 2. This act shall take effect and be in force from
145	and after July 1, 2018.
