## HOUSE BILL NO. 1353

AN ACT TO AUTHORIZE THE UNIVERSITY OF MISSISSIPPI MEDICAL
CENTER TO REARRANGE, DISINTER, REMOVE OR REINTER HUMAN REMAINS
REPOSING IN THE POTTER'S FIELD ON THE PROPERTY OF THE MEDICAL
CENTER TO A DIFFERENT LOCATION ON THE MEDICAL CENTER'S PROPERTY;
TO REPEAL SECTION 2, CHAPTER 846, LOCAL AND PRIVATE LAWS OF 1973,
AS AMENDED BY CHAPTER 854, LAWS OF 1974, WHICH AUTHORIZES THE
UNIVERSITY OF MISSISSIPPI MEDICAL CENTER TO TAKE CERTAIN ACTIONS
REGARDING HUMAN REMAINS IN THE POTTER'S FIELD ON ITS PROPERTY; AND
FOR RELATED PURPOSES.

- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 **SECTION 1.** (1) The University of Mississippi Medical Center
- 12 is authorized, in its discretion, to rearrange or disinter, remove
- 13 or reinter human remains reposing in the potter's field located on
- 14 the University of Mississippi Medical Center's property to a
- 15 different location on the medical center's property when the
- 16 disinterment, removal or reinterment is necessary for proper and
- 17 efficient maintenance and management.
- 18 (2) Markers, headstones, or other identification shall
- 19 accompany the remains whenever identification exists, and a record
- 20 of the removal and reinterment shall be maintained in the files of
- 21 the chancery clerk of Hinds County, Mississippi.

- 22 (3) Before taking any action authorized under this section,
- 23 the University of Mississippi Medical Center shall first advertise
- 24 its intent to rearrange, disinter, remove or reinter remains from
- 25 the property by publishing notice in a newspaper of the county
- 26 once a week for three (3) consecutive weeks.
- 27 (4) The University of Mississippi Medical Center and its
- 28 officers and employees shall be immune from any action or suit
- 29 arising from the maintenance or attempted maintenance of the
- 30 potter's field and the rearrangement, removal or reinterment of
- 31 remains, when performed in good faith under authority of this
- 32 section.
- 33 **SECTION 2.** Section 2, Chapter 846, Local and Private Laws of
- 34 1973, as amended by Chapter 854, Laws of 1974, which authorizes
- 35 the University of Mississippi Medical Center to take certain
- 36 actions regarding human remains in the potter's field on its
- 37 property, is repealed.
- 38 **SECTION 3.** This act shall take effect and be in force from
- 39 and after its passage.
