AN ACT MAKING AN APPROPRIATION FOR THE PURPOSE OF PAYING THE 2 EXPENSES AND PROVIDING CONTINGENT FUNDS FOR THE LEGISLATURE, THE EXPENSES OF THE JOINT LEGISLATIVE BUDGET COMMITTEE, THE EXPENSES OF THE JOINT LEGISLATIVE COMMITTEE ON PERFORMANCE EVALUATION AND 5 EXPENDITURE REVIEW, THE EXPENSES OF THE JOINT LEGISLATIVE 6 REAPPORTIONMENT COMMITTEE, THE EXPENSES OF THE JOINT COMMITTEE ON 7 COMPILATION, REVISION AND PUBLICATION OF LEGISLATION, PAYING THE MONTHLY EXPENSE ALLOWANCE OF THE MEMBERS OF THE LEGISLATURE, 8 9 PAYING THE STATE'S SHARE OF VARIOUS ASSESSMENTS, AND RELATED 10 PURPOSES, FOR THE FISCAL YEAR 2019. 11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 12 SECTION 1. The following sums, or so much thereof as may be 13 necessary, are appropriated out of any money in the State General Fund not otherwise appropriated, for the purpose of paying 14 15 salaries, mileage, insurance, matching funds and the daily expense allowance of the members of the Legislature for the Regular 16 17 Session of 2019 and providing contingent funds for the House of Representatives and Senate for the fiscal year beginning 18 July 1, 2018, and ending June 30, 2019, as follows: 19 20 For salaries, mileage, insurance, 21 matching funds and daily 22 expense allowance of members A1/2 H. 39	shall be given preference. A similar preference shall be given to
90	the Mississippi Industries for the Blind whenever purchases are
91	made without competitive bids.
