BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 7 SECTION 1. The following sum, or so much thereof as may be necessary, is reappropriated out of any money in the State 8 9 Treasury to the credit of Fund No. 3393100000 to the Department of 10 Finance and Administration, acting through the Bureau of Building, Grounds and Real Property Management, for the purpose of 11 12 reauthorizing the expenditure of funds previously appropriated for construction and/or repair and renovation projects at various 13 state agencies and institutions, as authorized in House Bill No. 14 15 1526, 2017 Regular Session, for the fiscal year beginning July 1, 2018, and ending June 30, 2019.....\$ 21,454,656.00. 16 17 This reappropriation is made for the purpose of reauthorizing the expenditure of special funds for construction and/or repair 18

19 and renovation projects at various state agencies and institutions 20 that had been authorized by the Legislature in prior fiscal years.

Notwithstanding the amount reappropriated under the provisions of this section, in no event shall the amount expended exceed the unexpended balance as of June 30, 2018, or change the purpose for which the funds were originally authorized.

The Bureau of Building, Grounds and Real Property 96 Management of the Office of General Services is expressly 97 authorized and empowered to receive, budget and expend any state, 98 local or other source funds designated for supplemental funding of 99 construction and/or repair and renovation projects.

100 SECTION 7. The money herein appropriated shall be paid by 101 the State Treasurer out of any money in the State Treasury to the 102 credit of the proper fund or funds as set forth in this act, upon 103 warrants issued by the State Fiscal Officer; and the State Fiscal 104 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 105 106 SECTION 8. This act shall take effect and be in force from 107 and after July 1, 2018.
