HOUSE BILL NO. 1616
(As Sent to Governor)

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE
2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF SPECIAL FUNDS
3 PREVIOUSLY APPROPRIATED FOR CONSTRUCTION AND/OR REPAIR AND
4 RENOVATION PROJECTS AT VARIOUS STATE AGENCIES AND INSTITUTIONS,
5 FOR FISCAL YEAR 2019.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** The following sum, or so much thereof as may be
8 necessary, is reappropriated out of any money in the State
9 Treasury to the credit of Fund No. 3393100000 to the Department of
10 Finance and Administration, acting through the Bureau of Building,
11 Grounds and Real Property Management, for the purpose of
12 reauthorizing the expenditure of funds previously appropriated for
13 construction and/or repair and renovation projects at various
14 state agencies and institutions, as authorized in House Bill No.
15 1526, 2017 Regular Session, for the fiscal year beginning July 1,
16 2018, and ending June 30, 2019.....\$ 21,454,656.00.

17 This reappropriation is made for the purpose of reauthorizing
18 the expenditure of special funds for construction and/or repair



19 and renovation projects at various state agencies and institutions
20 that had been authorized by the Legislature in prior fiscal years.

21 Notwithstanding the amount reappropriated under the
22 provisions of this section, in no event shall the amount expended
23 exceed the unexpended balance as of June 30, 2018, or change the
24 purpose for which the funds were originally authorized.

25 **SECTION 2.** The following sum, or so much thereof as may be
26 necessary, is reappropriated out of any money in any special fund
27 in the State Treasury to the credit of Fund 3390200000 to the
28 Department of Finance and Administration, acting through the
29 Bureau of Building, Grounds and Real Property Management, as
30 authorized in SB 2911, 2016 Regular Session, SB 2902, 2014 Regular
31 Session, and SB 2896, 2013 Regular Session, for the fiscal year
32 beginning July 1, 2018, and ending June 30, 2019.....
33\$ 3,035,543.00.

34 This reappropriation is made for the purpose of reauthorizing
35 the expenditure of Special Funds previously appropriated by the
36 Legislature in prior fiscal years for construction and/or repair
37 and renovation projects at various state agencies and
38 institutions.

39 Notwithstanding the amount reappropriated under the
40 provisions of this section, in no event shall the amount expended
41 exceed the unexpended balance as of June 30, 2018, or change the
42 purpose of which the funds were originally authorized.



43 **SECTION 3.** The following sum, or so much thereof as may be
44 necessary, is reappropriated out of any money in any special fund
45 in the State Treasury to the credit of Fund 3390300000 to the
46 Department of Finance and Administration, acting through the
47 Bureau of Building, Grounds and Real Property Management, as
48 authorized in HB 1526, 2017 Regular Session, for the fiscal year
49 beginning July 1, 2018, and ending June 30, 2019.....
50\$ 6,223,972.00.

51 This reappropriation is made for the purpose of reauthorizing
52 the expenditure of Special Funds previously appropriated by the
53 Legislature in prior fiscal years for construction and/or repair
54 and renovation projects at the Institutions of Higher Learning and
55 Community and Junior Colleges and various state agencies and
56 institutions.

57 Notwithstanding the amount reappropriated under the
58 provisions of this section, in no event shall the amount expended
59 exceed the unexpended balance as of June 30, 2018, or change the
60 purpose of which the funds were originally authorized.

61 **SECTION 4.** The following sum, or so much thereof as may be
62 necessary, is reappropriated out of any money in any special fund
63 in the State Treasury to the credit of Fund 6113000000 to the
64 Department of Finance and Administration, acting through the
65 Bureau of Building, Grounds and Real Property Management, as
66 authorized in SB 2924, 2016 Regular Session and HB 1526, 2017



67 Regular Session for the fiscal year beginning July 1, 2018, and
68 ending June 30, 2019.....\$ 8,200,000.00.

69 This reappropriation is made for the purpose of reauthorizing
70 the expenditure of Special Funds previously appropriated by the
71 Legislature in prior fiscal years for construction and/or repair
72 and renovation of Green Hall at the University of Southern
73 Mississippi and related purposes.

74 Notwithstanding the amount reappropriated under the
75 provisions of this section, in no event shall the amount expended
76 exceed the unexpended balance as of June 30, 2018, or change the
77 purpose of which the funds were originally authorized.

78 **SECTION 5.** The following sum, or so much thereof as may be
79 necessary, is reappropriated out of any money in the State
80 Treasury to the credit of Fund No. 6493C00000 to the Department of
81 Finance and Administration, acting through the Bureau of Building,
82 Grounds and Real Property Management, as authorized in Senate Bill
83 No. 3015, 2017 Regular Session, for the fiscal year beginning July
84 1, 2018, and ending June 30, 2019.....
85\$ 3,311,592.00.

86 This reappropriation is made for the purpose of reauthorizing
87 the expenditure of Special Funds previously appropriated by the
88 Legislature in prior fiscal years for upgrades and renovation of
89 the water treatment facility at the Alcorn State University and
90 related purposes.



91 Notwithstanding the amount reappropriated under the
92 provisions of this section, in no event shall the amount expended
93 exceed the unexpended balance as of June 30, 2018, or change the
94 purpose of which the funds were originally authorized.

95 **SECTION 6.** The Bureau of Building, Grounds and Real Property
96 Management of the Office of General Services is expressly
97 authorized and empowered to receive, budget and expend any state,
98 local or other source funds designated for supplemental funding of
99 construction and/or repair and renovation projects.

100 **SECTION 7.** The money herein appropriated shall be paid by
101 the State Treasurer out of any money in the State Treasury to the
102 credit of the proper fund or funds as set forth in this act, upon
103 warrants issued by the State Fiscal Officer; and the State Fiscal
104 Officer shall issue his warrants upon requisitions signed by the
105 proper person, officer or officers, in the manner provided by law.

106 **SECTION 8.** This act shall take effect and be in force from
107 and after July 1, 2018.
