## SENATE BILL NO. 2412

- AN ACT TO AMEND SECTION 89-5-24, MISSISSIPPI CODE OF 1972, TO REVISE DOCUMENT FORMATTING STANDARDS FOR MORTGAGES AND DEEDS OF TRUST FILED ON OR AFTER JANUARY 1, 2019, TO REQUIRE THAT THE LOAN AMOUNT AND MATURITY DATE MUST BE LISTED ON THE FIRST PAGE BELOW THE THREE-INCH MARGIN; AND FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 89-5-24, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 89-5-24. (1) Except as otherwise provided in subsections
- 10 (3) and (4), any document or instrument presented to the clerk of
- 11 the chancery court for recording shall meet the following
- 12 requirements:
- 13 (a) Each document or instrument shall consist of one or
- 14 more individual pages printed only on one (1) side. The document
- 15 or instrument shall not consist of pages that are permanently
- 16 bound or in a continuous form and shall not have any attachment
- 17 stapled or otherwise affixed to any page except as necessary to
- 18 comply with statutory requirements. However, the individual pages
- 19 of a document or instrument may be stapled together for

- 20 presentation for recording. A label that is firmly attached with
- 21 a bar code or return address may be accepted for recording.
- 22 (b) All documents must be printed or typed in a font no
- 23 smaller than ten-point in size. If a document or instrument,
- 24 other than a plat or survey or a drawing related to a plat or
- 25 survey, presented for recording contains type smaller than
- 26 ten-point type, the document or instrument shall be accompanied by
- 27 an exact typewritten or printed copy that meets the requirements
- 28 of this section.
- 29 (c) Each document shall be of sufficient legibility to
- 30 produce a clear reproduction. If a document or instrument, other
- 31 than a plat or survey or a drawing related to a plat or survey, is
- 32 not sufficiently legible to produce a clear reproduction, the
- 33 document or instrument shall be accompanied by an exact
- 34 typewritten or printed copy that meets the type size requirements
- 35 of paragraph (b) and shall be recorded contemporaneously as
- 36 additional pages of the document or instrument.
- 37 (d) Each document or instrument, other than a plat or
- 38 survey or a drawing related to a plat or survey, shall be on white
- 39 paper of not less than twenty-pound weight. All text within the
- 40 document or instrument shall be of sufficient color and clarity to
- 41 ensure that the text is readable when reproduced from the record.
- 42 (e) All signatures on a document or instrument shall be
- 43 in black or blue ink and of sufficient color and clarity to ensure
- 44 that the signatures are of sufficient legibility to produce a

- 45 clear reproduction when the document or instrument is reproduced
- 46 from the record. The corresponding name shall be typed, printed
- 47 or stamped beneath the original signature. The typing or printing
- 48 of a name or the application of an embossed or inked stamp shall
- 49 not cover or otherwise materially interfere with any part of the
- 50 document or instrument except where provided by law. Failure to
- 51 print or type signatures as required in this paragraph does not
- 52 invalidate the document or instrument.
- 53 (f) The first page of each document or instrument,
- 54 other than a plat or survey or a drawing related to a plat or
- 55 survey, shall have a top margin of at least three (3) inches of
- 56 vertical space from left to right which shall be reserved for the
- 57 recorder's use. All other margins on the document or instrument
- 58 shall be a minimum of three-fourths (3/4) of one (1) inch.
- 59 Nonessential information including, but not limited to, form
- 60 numbers or customer notations may be placed in a margin other than
- 61 the top margin. A document may be recorded if a minor portion of
- 62 a seal or incidental writing extends into a margin. The recorder
- 63 shall not incur any liability for failure to show a seal or
- 64 information that extends beyond the margin of the permanent
- 65 archival record.
- 66 (2) Each document or instrument, other than a plat or survey
- 67 or a drawing related to a plat or survey, that is presented for
- 68 recording and that contains any of the following information shall

- 69 have that information on the first page below the three-inch
- 70 margin:
- 71 (a) The name, physical business mailing address and
- 72 business or employment telephone number of the individual who
- 73 prepared the document; and the name, mailing address and telephone
- 74 number of every grantor, grantee, borrower, beneficiary, trustee
- 75 or other party to the instrument.
- 76 (b) A return address.
- 77 (c) The title of the document or instrument.
- 78 (d) Any address and telephone number required by
- 79 Section 27-3-51, Mississippi Code of 1972.
- 80 (e) The legal description of the property or indexing
- 81 instruction per Section 89-5-33(3). If there is insufficient
- 82 space on the first page for the entire legal description or the
- 83 entire indexing instruction, immediately succeeding pages shall be
- 84 used.
- (f) From and after July 1, 2019, if the document or
- 86 instrument is a mortgage or deed of trust, the loan amount and
- 87 final maturity date.
- 88 (3) The following documents or instruments are exempt from
- 89 the format requirements of this section:
- 90 (a) A document or instrument that was executed before
- 91 July 1, 2009.
- 92 (b) A military separation document or instrument.

- 95 (d) A certified copy of a document or instrument issued
- 96 by a court or governmental agency, including a vital record.
- 97 (e) A document or instrument where one (1) of the
- 98 original parties is deceased or otherwise incapacitated.
- 99 (f) A document or instrument formatted to meet court
- 100 requirements.
- 101 (q) A federal tax lien.
- 102 (h) A filing under the Uniform Commercial Code.
- 103 (4) The recorder shall record a document or instrument that
- 104 does not substantially conform to the format standards specified
- 105 in subsections (1) and (2) of this section upon payment of an
- 106 additional recording fee of Ten Dollars (\$10.00) per document or
- 107 instrument. The fee \* \* \* may not be charged for those documents
- 108 or instruments specifically exempted in subsection (3).
- 109 (5) Failure to conform to the format standards specified in
- 110 this section does not affect the validity or enforceability of the
- 111 document or instrument.
- 112 **SECTION 2.** This act shall take effect and be in force from
- 113 and after July 1, 2018.
