- 46 **SECTION 6.** Of the funds appropriated herein, up to One
- 47 Million Dollars (\$1,000,000.00) shall be expended from the Work
- 48 Force Carryover Fund as created by House Bill No. 1271, 1995
- 49 Regular Session.
- SECTION 7. Of the funds appropriated in Sections 1 and 2,
- 51 funds in the amount of Fifty Million Eight Hundred Thirty-one
- 52 Thousand Eight Hundred Two Dollars (\$50,831,802.00) are
- 53 appropriated for the Workforce Education Program and Industrial
- 54 Training. No funding obligation or commitment shall be made on
- 55 behalf of the state for industrial training beyond the level of
- 56 funding made available in this section. All industrial training
- 57 program commitments made in Fiscal Year 2019 and future fiscal
- 58 years shall be based only upon funds available in this section and
- 59 any proposed commitments shall be approved by the Executive

Of the funds appropriated in Section 2, funds in 69 the amount of Twenty-eight Million Dollars (\$28,000,000.00) shall 70 be derived from unemployment compensation contributions deposited 71 into the Mississippi Workforce Enhancement Training Fund and shall 72 be utilized exclusively by the Mississippi Community College Board 73 for workforce training in accordance with Senate Bill No. 2027, 74 2010 Regular Session. It is the intention of the Legislature that 75 the Workforce Enhancement Training Fund shall have not less than 76 Two Million Dollars (\$2,000,000.00) set aside as a carry-forward 77 to begin the Fiscal Year 2020 Workforce Education Program. 78 SECTION 9. Of the funds appropriated in Section 2, funds in 79 the amount of Two Million Five Hundred Thousand Dollars
- 80 (\$2,500,000.00) shall be derived from fees charged for the 81 Workforce Online Training Program, and the Mississippi Virtual
- 82 Community College and funds in the amount of Three Million Four
- 83 Hundred Sixty Thousand Dollars (\$3,460,000.00) shall be
- 84 transferred from the Community and Junior College Education
- 85 Technology Fund for the purpose of defraying the costs of the
- 86 Mississippi Virtual Community College, the Workforce Online
- 87 Training Program and the administrative expenses of the
- 88 Mississippi Community College Board.
- 89 **SECTION 10.** Of the funds appropriated under the provisions
- 90 of Section 2, funds in the amount of One Hundred Twenty-five
- 91 Thousand Dollars (\$125,000.00) shall be derived from fees charged
- 92 for issuing duplicate transcripts and duplicate diplomas for the

- 93 High School Equivalency Testing Program for the purpose of
- 94 defraying the costs of administering the High School Equivalency
- 95 Testing Program of the Mississippi Community College Board, in
- 96 accordance with Senate Bill No. 2626, 2002 Regular Session.
- 97 **SECTION 11.** Of the funds appropriated in Section 2, funds in
- 98 the amount of Thirty Million Dollars (\$30,000,000.00) shall be
- 99 derived from the transfer of postsecondary vocational and
- 100 technical funds from the Mississippi Department of Education to
- 101 the Mississippi Community College Board for the purpose of
- 102 managing the day-to-day operations of postsecondary career and
- 103 technical education.
- 104 **SECTION 12.** Of the funds appropriated in Section 1, Five
- 105 Hundred Forty-two Thousand Four Hundred Fifty-nine Dollars
- 106 (\$542,459.00) is provided to the Mississippi Community College
- 107 Board for the purpose of defraying the cost of the Greenville
- 108 Higher Education Center.
- 109 **SECTION 13.** Of the funds provided in Sections 1 and 2, up to
- One Million One Hundred Seven Thousand Dollars (\$1,107,000.00)
- 111 shall be used to implement dual enrollment opportunities in
- 112 practical nursing programs for secondary students.
- 113 **SECTION 14.** It is the intention of the Legislature that
- 114 whenever two (2) or more bids are received by this agency for the
- 115 purchase of commodities or equipment, and whenever all things
- 116 stated in such received bids are equal with respect to price,
- 117 quality and service, the Mississippi Industries for the Blind

- 118 shall be given preference. A similar preference shall be given to
- 119 the Mississippi Industries for the Blind whenever purchases are
- 120 made without competitive bids.
- 121 **SECTION 15.** It is the intention of the Legislature that an
- amount equal to One Dollar and Fifty Cents (\$1.50) per square foot
- 123 shall be transferred to the Executive Office of the State Board of
- 124 Institutions of Higher Learning to defray utility costs.
- 125 **SECTION 16.** Of the funds appropriated under the provisions
- of this act, Two Hundred Fifty-six Thousand Dollars (\$256,000.00)
- 127 shall be derived from the Education Enhancement Fund from funds
- deposited pursuant to Sections 27-65-75 and 27-67-31, Mississippi
- 129 Code of 1972.
- SECTION 17. Of the funds appropriated in Section 1,
- 131 Thirty-seven Thousand Six Hundred Twenty-six Dollars (\$37,626.00)
- 132 is provided for geospatial site licenses.
- 133 **SECTION 18.** It is the intention of the Legislature that the
- 134 funds herein appropriated shall be expended in compliance with
- 135 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 136 shall incur obligations or indebtedness in excess of their
- 137 appropriation and that the responsible officers, either personally
- 138 or upon their official bonds, shall be held responsible for
- 139 actions contrary to this provision.
- 140 **SECTION 19.** The money herein appropriated shall be paid by
- 141 the State Treasurer out of any money in the State Treasury to the
- 142 credit of the proper fund or funds as set forth in this act, upon
