SENATE CONCURRENT RESOLUTION NO. 550

- A CONCURRENT RESOLUTION RECOGNIZING THE LEGACY OF CIVIL RIGHTS TRAILBLAZER FLONZIE "GOODLOE" BROWN-WRIGHT OF FARMHAVEN AND CANTON, MISSISSIPPI, THE FIRST AFRICAN-AMERICAN FEMALE ELECTED TO
- 4 PUBLIC OFFICE IN MISSISSIPPI SINCE RECONSTRUCTION, AND COMMENDING
- 5 HER ADVOCACY.
- 6 WHEREAS, an advocate for the less fortunate among us and for
- 7 equal rights, Flonzie "Goodloe" Brown-Wright, best-selling author,
- 8 Civil Rights Trailblazer and native of rural Farmhaven,
- 9 Mississippi, is the only daughter of Frank and Littie P. Brown.
- 10 She and her brothers, Sydney and Frank, Jr., grew up in Canton, 16
- 11 miles west of her birthplace. Both parents, brothers and eldest
- 12 son, Edward, are deceased. She is the mother of two children,
- 13 Cynthia and Lloyd; and
- 14 WHEREAS, she attended both public and private schools at
- 15 Farmhaven and Canton, Mississippi. She received a Fain Fellowship
- 16 and attended Tougaloo College in Tougaloo, Mississippi. Special
- 17 courses included: Pre-Law, Black History and Political Science.
- 18 She graduated from the Institute of Politics at Millsaps College

- 19 in Jackson and served as Vice President of the institute where she
- 20 taught "Grassroots Organizing and Campaign Management"; and
- 21 WHEREAS, she was inspired to become involved in the
- 22 Mississippi Civil Rights Movement in 1963, after the assassination
- 23 of Medgar Evers, Field Secretary for the State NAACP. Her
- 24 inspiration continues in a myriad of creative community
- 25 initiatives across the country, where she lectures and provides
- 26 motivational opportunities to a cross section of audiences. Her
- 27 appointment to the U.S. Equal Employment Opportunity Commission
- 28 (EEOC) as an Investigator was confirmed in 1974. She retired from
- 29 the EEOC in 1989 with special citations, including the Chairman's
- 30 Service Award, and is a member of New Hope Baptist Church in
- 31 Jackson, Mississippi; and
- 32 WHEREAS, she was the first African-American female in 1968 to
- 33 be elected to a public office in Mississippi since and perhaps
- 34 pre-Reconstruction. The position of Election Commissioner allowed
- 35 her to correct many voting injustices. She appointed and trained
- 36 numerous African-Americans to conduct elections, many of whom
- 37 still continue to serve; and
- 38 WHEREAS, in 1994, she authored and published her first book,
- 39 Looking Back to Move Ahead. In 1999, the publication became a
- 40 best seller for an independent author. The book chronicles her
- 41 years growing up in a small rural Mississippi town. It also
- 42 focuses on the involvement of scores of unrecognized heroes and
- 43 sheroes who were similarly involved in the Civil Rights Movement

- 44 in the 1960s and 1970s in Canton, Madison County and the State of
- 45 Mississippi. She knew and worked with Dr. Martin Luther King,
- 46 Jr., and many other humanitarian activists, both locally and
- 47 nationally. She is the recipient of more than 400 Community
- 48 Service Awards, including special honors from LeMoyne College in
- 49 Syracuse, New York, and an honor at the Kennedy Center in
- 50 Washington, D.C. She is listed in Who's Who Among Black
- 51 Americans, 1994/1995 edition, and is a member of the National
- 52 Association of Female Executives. She is among a number of
- 53 prestigious African-Americans listed in Who's Who Among Black
- 54 *Mississippians*; and
- 55 WHEREAS, she is President and CEO of FBW & Associates,
- 56 Incorporated of Jackson, Mississippi, a freelance marketing
- 57 consultant firm, and is founder of the Flonzie B. Wright
- 58 Scholarship Fund, a fund designed to encourage students to stay in
- 59 school. Since its inception, the fund has provided more than
- 60 \$40,000.00 in scholarship incentives to many students; and
- 61 WHEREAS, during the summer of 1997, she participated in
- 62 filming a documentary, Standing on My Sisters' Shoulders,
- 63 sponsored by the University of Mississippi and produced by Sadoff
- 64 Productions. This award-winning film focuses on a number of
- 65 women, both black and white, who were involved in the Southern
- 66 Civil Rights Movement. She and others were honored for this
- 67 production at the John F. Kennedy Center for the Performing Arts.
- 68 She was featured in the nationally acclaimed Purpose Magazine, the

- 69 January 1998 edition, and Tomorrow's South, the September 1999
- In April 1999, she produced a Video Documentary, And 70
- 71 Before I'll Be Your Slave. This docudrama is a testament to her
- 72 ancestors and shares many stories which have impacted her life.
- 73 She is featured and served as an Advisor to Jennifer
- 74 Cheeks-Collins, also of Canton, in her publication, Black America
- 75 Series, Madison County, Mississippi. In October 2008, she
- 76 released Standing Tall in Tough Times on DVD. Among other
- 77 interviews, her parents tell of their challenges because of her
- 78 involvement in Civil Rights. Included also is her August 2008
- 79 Keynote Speech in Dayton, Ohio, the night President Barack Obama
- 80 accepted the Democratic Party's Presidential Nomination. From
- 81 2005-2010, she served Miami University in Middletown, Ohio, as
- 82 Student Affairs Scholar in Residence where she co-wrote and taught
- a new curriculum, "Black Issues in Higher Education." 83
- 84 Subsequently, she served the university as an Adjunct Professor.
- 85 Her credits, memberships and honors are extensive; and
- 86 WHEREAS, in 2011, she accepted the appointment as Co-Event
- 87 Director for the 50th Anniversary of the Mississippi Freedom
- 88 Riders Reunion. Her excellent skills in assisting with the
- 89 planning and execution were demonstrated in the success of this
- 90 historical celebration. She was recently appointed as a
- 91 Commissioner at Tougaloo College by President Beverly Hogan to
- 92 assist in promoting the celebration of a number of Civil Rights
- 93 events culminating in 2014. Even though her travels have been

- 94 extensive and her achievements many, she simply refers to herself
- 95 as "Just a Country Girl from Mississippi who Loves the Lord and
- 96 ALL People":
- 97 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 98 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 99 we do hereby recognize the legacy of Civil Rights Trailblazer
- 100 Flonzie "Goodloe" Brown-Wright of Farmhaven and Canton,
- 101 Mississippi, the first African-American female elected to public
- 102 office in Mississippi since Reconstruction, and commending her
- 103 advocacy.
- BE IT FURTHER RESOLVED, That this resolution be presented to
- 105 Flonzie Brown-Wright, forwarded to the Mississippi Department of
- 106 Archives and History, and made available to the Capitol Press
- 107 Corps.
