SENATE CONCURRENT RESOLUTION NO. 566

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING THE 2 SIMPSON COUNTY ACADEMY CROSS COUNTRY "LADY COUGARS" FOR WINNING 3 THE 2017 MAIS DIVISION II STATE CHAMPIONSHIP.

WHEREAS, we join the students, coaches, parents and faculty of Simpson County Academy in honoring the "Lady Cougars" Cross Country Team for winning the 2017 MAIS Division II State Championship; and

WHEREAS, the young team competed in Varsity Meets for the 8 9 majority of the season. Simpson County Academy opened the cross country season on August 28, 2017, at the Jackson Academy 10 11 Invitational. They finished 7th with a team average of 19:32 for a 4k. The field that finished in front of Simpson County Academy 12 was comprised of Division I schools, with the exception of Lamar 13 14 who finished fifth. August 28, 2017, would be the first and last 15 time during the season that Simpson County Academy was defeated by 16 anyone in their division. They raced again on September 11th at the Jackson Prep Invitational, finishing 6th right ahead of Lamar. 17 18 For the next four meets, Simpson County Academy held a 5th place

19 overall team finish and was second to none among Division II 20 schools. At the Cathedral Cross Country Invitational, the team raced under the Junior Varsity Division and won with 17 points 21 22 over Silliman Institute. The win at Cathedral foreshadowed what 23 was to come on October 24th at the MAIS AMA Division II Overall 24 Varsity State Meet. Simpson won the Meet coming in with 46 points 25 and improving their team average by over a minute, now averaging a 26 time of 18:23 for a 4k; and

27 WHEREAS, the team was coached by Emily Craft and included 6th 28 graders, Callie Grace Clayburn and Claire Mitchell; 7th graders: 29 Carson Carter, Elliot Rankin, Bailey Blakeney, Mary Madelyn 30 Grubbs, Emma Wallace and Emma Overstreet; 8th graders, Cameron 31 Bishop and Mary Margaret Rankin; 9th graders, Blair Smith and Mary 32 Margaret White; and All-State Carson Carter and Mary Margaret 33 Rankin; and

34 WHEREAS, Coach Craft commented, "The girls really worked hard 35 this season and remained dedicated to the goal. They proved they 36 knew not only how to run well, but how to race well and that is 37 what made us Champions"; and
