- SECTION 6. (1) MDA shall be the administrator of the Gulf
 Coast Restoration Fund. MDA is authorized to carry out any powers
 and duties authorized in this act and shall handle all of the
 day-to-day matters relating to the GCRF.
- 155 The annual administration expenses of MDA in carrying 156 out its duties under this act shall not exceed one percent (1%) of 157 the amount of the funds deposited into the GCRF under Section 158 27-103-302 for that year. MDA may recover from applicants and 159 recipients of funds under this act a portion of the costs 160 associated with administering assistance provided under this act, 161 which shall not be subject to the one percent (1%) limitation 162 under this subsection.
 - SECTION 7. (1) Applicants who are eligible for assistance under this section include, but are not limited to, local units of government, nongovernmental organizations, institutions of higher learning, community colleges, ports, airports, public-private partnerships, private for-profit entities, private non profit entities and local economic development entities. Projects that are eligible for assistance under this section are projects that have the potential to generate increased economic activity in the region, as described in Section 8(3) of this act.
