HOUSE BILL NO. 724 (As Passed the House)

1 AN ACT TO DESIGNATE A SEGMENT OF MISSISSIPPI HIGHWAY 537 IN 2 JONES COUNTY, MISSISSIPPI, AS THE "WINNIE FROST MORGAN MEMORIAL 3 HIGHWAY"; TO DESIGNATE A SEGMENT OF MISSISSIPPI HIGHWAY 370 IN LEE COUNTY, MISSISSIPPI, AS THE "DALEN KEITH THOMAS MEMORIAL HIGHWAY"; 4 5 TO DESIGNATE A SEGMENT OF MISSISSIPPI HIGHWAY 370 IN LEE COUNTY, 6 MISSISSIPPI, AS THE "LELAND "L.R." BURCHAM MEMORIAL HIGHWAY"; TO DESIGNATE AN INTERSECTION OF MISSISSIPPI HIGHWAY 370 IN LEE 7 COUNTY, MISSISSIPPI, AS THE "LENOISE DAVIDSON MEMORIAL 8 INTERSECTION"; AND FOR RELATED PURPOSES. 9

- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 **SECTION 1.** (1) The segment of Mississippi Highway 537 in
- 12 Jones County, Mississippi, beginning at its intersection with
- 13 Mississippi Highway 15/Matthews Road and extending northeasterly
- 14 to its intersection with the Jones/Jasper County Line near the
- 15 unincorporated community of Moss, Mississippi, is designated as
- 16 the "Winnie Frost Morgan Memorial Highway."
- 17 (2) The Mississippi Department of Transportation shall erect
- 18 and maintain appropriate signs along and approaching the segment
- 19 of highway described in subsection (1) of this section.

- 20 **SECTION 2.** (1) The segment of Mississippi Highway 370 in
- 21 Lee County, Mississippi, beginning at its intersection with County

- 22 Road 2788 and extending southerly to its intersection with County
- 23 Road 1503, is designated as the "Dalen Keith Thomas Memorial
- 24 Highway."
- 25 (2) The Mississippi Department of Transportation shall erect
- 26 and maintain appropriate signs along and approaching the segment
- 27 of highway described in subsection (1) of this section.
- SECTION 3. (1) The segment of Mississippi Highway 370 in
- 29 Lee County, Mississippi, beginning at its intersection with County
- 30 Road 2788 and extending northerly to its intersection with
- 31 Mississippi Highway 366, is designated as the "Leland "L.R."
- 32 Burcham Memorial Highway."
- 33 (2) The Mississippi Department of Transportation shall erect
- 34 and maintain appropriate signs along and approaching the segment
- 35 of highway described in subsection (1) of this section.
- 36 **SECTION 4.** (1) The intersection of Mississippi Highway 370
- 37 with County Road 2788 in Lee County, Mississippi, is designated as
- 38 the "Lenoise Davidson Memorial Intersection."
- 39 (2) The Mississippi Department of Transportation shall erect
- 40 and maintain appropriate signs along and approaching the
- 41 intersection described in subsection (1) of this section.
- 42 **SECTION 5.** This act shall take effect and be in force from
- 43 and after July 1, 2019.
