- 52 served as a Parish Council Member, an Education Committee Member

- 54 Conception Catholic Church, and she is active with the Jones
- 55 County Relay for Life and Jones County Heart Walk each year; and

- 57 with disabilities, Ms. Brett's consistency in performance has

- 59 her dedication and commitment to her community and to the State of
