## COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 2847

AN ACT TO AMEND SECTION 41-115-1, MISSISSIPPI CODE OF 1972, TO PROHIBIT THE USE OF TANNING DEVICES AT TANNING FACILITIES BY CHILDREN UNDER AGE 18; TO ASSESS A CIVIL PENALTY FOR VIOLATIONS OF THIS SECTION; TO REQUIRE TANNING FACILITIES TO POST A NOTICE 5 DEVELOPED BY THE MISSISSIPPI STATE DEPARTMENT OF HEALTH STATING IT 6 IS UNLAWFUL FOR A TANNING FACILITY OWNER OR OPERATOR TO ALLOW A 7 PERSON UNDER THE AGE OF 18 TO USE ANY TANNING DEVICE; TO REQUIRE 8 TANNING FACILITIES TO POST A NOTICE DEVELOPED BY THE MISSISSIPPI 9 STATE DEPARTMENT OF HEALTH STATING THAT A TANNING FACILITY OR 10 OPERATOR THAT VIOLATES THIS SECTION IS SUBJECT TO A CIVIL PENALTY; TO REQUIRE TANNING FACILITIES TO POST A NOTICE DEVELOPED BY THE 11 12 MISSISSIPPI STATE DEPARTMENT OF HEALTH STATING THAT AN INDIVIDUAL 13 MAY REPORT VIOLATIONS OF THIS SECTION TO THE MISSISSIPPI STATE DEPARTMENT OF HEALTH STATING THE HEALTH RISKS ASSOCIATED WITH 14 15 TANNING; TO REQUIRE THE OPERATOR TO REQUIRE PHOTO IDENTIFICATION 16 INDICATING THAT THE PERSON USING A TANNING DEVICE IS AT LEAST 18 17 YEARS OF AGE; AND FOR RELATED PURPOSES. 18 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 19 SECTION 1. Section 41-115-1, Mississippi Code of 1972, is 20 amended as follows: 21 41-115-1. (1) As used in this section: 22 (a) "Tanning device" means any equipment that emits 23 radiation having wavelengths in the air between two hundred (200)

and four hundred (400) nanometers and that is used for tanning of

the skin, such as a sunlamp, tanning booth or tanning bed, and

57	and each year thereafter:

61	(b) * * * That a tanning facility or operator that
62	violates the provisions of this section shall be subject to a
63	civil penalty;
64	(c) That an individual may report a violation of the
65	provisions of this section to the Mississippi State Department of
66	Health; and
67	(d) The health risks associated with tanning,
68	including, but not limited to, skin cancer, premature aging of
69	skin, burns to the skin, and adverse reactions to certain
70	medications, foods, and cosmetics.
71	(5) The operator shall require each person using a tanning

device to provide a driver's license or other photo identification

indicating that the person is at least eighteen (18) years of age.

75	(6) <b>Duties of owner.</b> The owner, lessee or operator of a
76	tanning facility shall ensure that all of the following
77	requirements are fulfilled:
78	(a) No customer under eighteen (18) years of age is
79	permitted to use the tanning facility. (Proof of age may be
30	satisfied with a driver's license or other government-issued
31	identification containing the date of birth and photograph of the
32	<pre>individual.)</pre>
33	(b) During operating hours there is present at the
3 4	tanning facility a trained operator who is able to inform
35	customers about, and assist customers in, the proper use of
36	tanning devices.
37	(c) Each tanning device is properly sanitized after
88	each use.
39	(d) Each customer, before he or she begins to use a
90	tanning device, is provided with properly sanitized and securely
91	fitting protective eyewear that protects the wearer's eyes from
92	ultraviolet radiation and allows enough vision to maintain balance
93	at no cost.
94	(e) Customers are not allowed to use a tanning device
95	unless the customer uses protective eyewear.
96	(f) Each customer is shown how to use such physical
97	aids as handrails and markings on the floor to maintain a proper
98	exposure distance from the tanning device as recommended by the
99	manufacturer.

100	(g) A timing device that is accurate within ten percent
101	(10%) of any selected timer interval is used and is remotely
102	located so customers cannot set their own exposure time.
103	(h) Each tanning device is equipped with a mechanism
104	that allows the customer to turn the tanning device off.
105	(i) Each customer is limited to the maximum exposure
106	time recommended by the manufacturer for their skin type.
107	(j) Customers are not allowed to use a tanning device
108	more than once every twenty-four (24) hours.
109	(k) The interior temperature of the tanning facility
110	does not exceed one hundred (100) degrees Fahrenheit.
111	(1) Maintain the following records: copies of all
112	consent forms issued by customers; a record of each consumer's
113	total number of tanning visits at the facility; the dates and
114	durations of tanning exposures; and any injury reports for a
115	period of three (3) years after exposure for each customer.
116	(7) <b>Duties of user.</b> No person may use a tanning device of a
117	tanning facility unless he or she complies with all of the
118	<pre>following:</pre>
119	(a) Immediately before the customer's first use of a
120	unique tanning facility in a year, sign a statement acknowledging
121	that he or she has read and understands the notice and the warning
122	sign required under this section, and specifying that the customer
123	agrees to use protective eyewear.

124	(b) Use protective eyewear at all times while using a
125	tanning device.
126	( * * $\star$ 8) This section * * * shall not apply to * * * any
127	physician who is duly licensed to practice medicine in this state
128	and who, in the practice of medicine, uses a phototherapy device
129	with respect to a patient of any age.
130	SECTION 2. This act shall take effect and be in force from
131	and after July 1, 2019, and shall stand repealed from and after
132	June 30, 2019.
