- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 **SECTION 1.** (1) That portion of Mississippi Highway 25 from
- 12 the city limits of Aberdeen, Monroe County, Mississippi, to
- 13 Highway 382, is designated and shall be known as the "Thomas Lee
- 14 Bales Memorial Highway."
- 15 (2) The Mississippi Department of Transportation shall erect
- 16 and maintain appropriate signs along and approaching the portion
- 17 of highway described in subsection (1) of this section.
- 18 **SECTION 2.** (1) That portion of United States Highway 51
- 19 within the city limits of Duck Hill, Montgomery County,
- 20 Mississippi, is designated and shall be known as the "Lucie E.
- 21 Campbell Memorial Highway."

22	(2) The Mississippi Department of Transportation shall erect
23	and maintain appropriate signs along and approaching the portion
24	of highway described in subsection (1) of this section.

- 25 <u>SECTION 3.</u> (1) That portion of United States Highway 61 26 within the city limits of Shaw, Bolivar County, Mississippi, is 27 designated and shall be known as the "Andrew and Mary Lou Hawkins 28 Memorial Highway."
- 29 (2) The Mississippi Department of Transportation shall erect 30 and maintain appropriate signs along and approaching the portion 31 of highway described in subsection (1) of this section.
- 32 <u>SECTION 4.</u> (1) That portion of United States Highway 72
 33 within the corporate limits of the City of Iuka, Tishomingo
 34 County, Mississippi, is designated and shall be known as the
 35 "Mayor Johnny Biggs Memorial Highway."
- 36 (2) The Mississippi Department of Transportation shall erect 37 and maintain appropriate signs along and approaching the portion 38 of highway described in subsection (1) of this section.
- 39 **SECTION** $\underline{5}$. This act shall take effect and be in force from 40 and after July 1, 2019.
