- No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.
- 23 SECTION 3. It is the intention of the Legislature that the 24 Mississippi Ethics Commission shall maintain complete accounting and personnel records related to the expenditure of all funds 25 26 appropriated under this act and that such records shall be in the 27 same format and level of detail as maintained for Fiscal Year 2019. It is further the intention of the Legislature that the 28 29 agency's budget request for Fiscal Year 2021 shall be submitted to 30 the Joint Legislative Budget Committee in a format and level of 31 detail comparable to the format and level of detail provided 32 during the Fiscal Year 2020 budget request process.
- 33 SECTION 4. It is the intention of the Legislature that 34 whenever two (2) or more bids are received by this agency for the 35 purchase of commodities or equipment, and whenever all things stated in such received bids are equal with respect to price, 36 37 quality and service, the Mississippi Industries for the Blind 38 shall be given preference. A similar preference shall be given to 39 the Mississippi Industries for the Blind whenever purchases are 40 made without competitive bids.
- SECTION 5. It is the intention of the Legislature, that of the funds provided in Section 1, the Ethics Commission is hereby

- authorized to purchase and pay premiums for casualty insurance on passenger vehicles owned and operated by the agency.
- 45 **SECTION 6.** It is the intention of the Legislature that the
- 46 funds herein appropriated shall be expended in compliance with
- 47 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 48 shall incur obligations or indebtedness in excess of their
- 49 appropriation and that the responsible officers, either personally
- 50 or upon their official bonds, shall be held responsible for
- 51 actions contrary to this provision.
- 52 **SECTION 7.** The money herein appropriated shall be paid by
- 53 the State Treasurer out of any money in the State Treasury to the
- 54 credit of the proper fund or funds as set forth in this act, upon
- 55 warrants issued by the State Fiscal Officer; and the State Fiscal
- 56 Officer shall issue his warrants upon requisitions signed by the
- 57 proper person, officer or officers, in the manner provided by law.
