33 **SECTION 4.** It is the intention of the Legislature that 34 whenever two (2) or more bids are received by this agency for the 35 purchase of commodities or equipment, and whenever all things 36 stated in such received bids are equal with respect to price, 37 quality and service, the Mississippi Industries for the Blind shall be given preference. It is the intention of the Legislature that the 42 Executive Department shall maintain complete accounting and personnel records related to the expenditure of all funds 43 appropriated under this act and that such records shall be in the 44 45 same format and level of detail as maintained for Fiscal Year 46 2019. It is further the intention of the Legislature that the 47 agency's budget request for Fiscal Year 2021 shall be submitted to 48 the Joint Legislative Budget Committee in a format and level of 49 detail comparable to the format and level of detail provided 50 during the Fiscal Year 2020 budget request process.

51 **SECTION 6.** The money herein appropriated shall be paid by 52 the State Treasurer out of any money in the State Treasury to the 53 credit of the proper fund or funds as set forth in this act, upon 54 warrants issued by the State Fiscal Officer; and the State Fiscal 55 Officer shall issue his warrants upon requisitions signed by the 56 proper person, officer or officers, in the manner provided by law. 57 SECTION 7.
