- 3 SECTION *. Chapter 386, Laws of 2017, as amended by Section
- 4 3, Chapter 449, Laws of 2018, is amended as follows:
- 5 Section 2. (1) The Department of Finance and
- 6 Administration, acting on behalf of the Mississippi Department of
- 7 Human Services, is authorized to transfer and convey to the Marion
- 8 County Economic Development District certain real property located
- 9 at Columbia Training School in Marion County, Mississippi, for the
- 10 purpose of providing unobstructed access for the industrial
- 11 development of the Marion County AirPlex on the property
- 12 transferred under subsection (2)(a) of Section 1 of this chapter.



- 13 The real property contains approximately forty (40) acres, more or
- 14 less, and is more particularly described as follows:
- Beginning at a found concrete monument at the Southeast corner of 15
- Section 21, Township 4 North, Range 18 West, Marion County, 16
- 17 Mississippi, and run westerly along the southern boundary of
- 18 Section 21 for a distance of 975.58 feet, more or less, to the
- easternmost right-of-way line of Airport Road. 19 Thence run in a
- 20 southeasterly direction along said right-of-way line the following
- 21 calls; run along a curve to the right having an arc length of
- 261.47 feet, a radius of 735.00 feet, a chord distance of 260.09 22
- 23 feet, and a chord bearing of South 31 degrees 52 minutes 25
- 24 seconds East; thence continue along said right-of-way line South
- 25 21 degrees 40 minutes 56 seconds East a distance of 1,480.92 feet;
- 26 thence leaving said right-of-way line run North 43 degrees 58
- 27 minutes 36 seconds East a distance of 2,219.24 feet, more or less,
- 28 to the north boundary line of Section 27; thence run westerly
- 29 along said north boundary line of Section 27 for a distance of
- 1,249.87 feet back to the Point of Beginning. Said parcel 30
- 31 containing 40.0 acres, more or less, and being located in the SE
- 1/4 of the NE 1/4 of Section 28 and the NE 1/4 of the NE 1/4 of 32
- 33 Section 28 and the SE 1/4 of the NE 1/4 of Section 28 and the NW
- 1/4 of the NW 1/4 of Section 27, Township 4 North, Range 18 West, 34
- Marion County, Mississippi. 35
- 36 The State of Mississippi shall retain any mineral rights (2)
- to the property transferred and conveyed under subsection (1) of 37

- 38 this section. The Department of Finance and Administration shall
- 39 have the authority to correct any discrepancies in the property
- 40 descriptions provided in subsection (1) of this section.
- 41 (3) The parcels of property conveyed under this section must
- 42 be conveyed to the Marion County Economic Development District
- 43 without any assumption of liability or financial responsibility by
- 44 the State of Mississippi for any known or unknown environmental
- 45 defects contained thereon. Upon receipt of the deed of title to
- 46 the property, the Marion County Economic Development District
- 47 shall indemnify the State of Mississippi for any damage, injury or
- 48 loss.
- 49 **SECTION *.** Section 43-27-39, Mississippi Code of 1972, is
- 50 amended as follows:
- 51 43-27-39. (1) The purpose of this section is to ensure that
- 52 Mississippi's juvenile justice system is cost-efficient and
- 53 effective at reducing juvenile crime and to create a continuum of
- 54 options for Mississippi's youth court judges so that they are
- 55 better equipped to protect our communities and to care for our
- 56 children.
- 57 (2) The Columbia Training School shall no longer operate as
- 58 a secure training school for juvenile delinguents. All youth,
- 59 both male and female, committed to the custody of the Department
- of Human Services and adjudicated to training school shall be
- 61 housed at the Oakley Youth Development Center. The Oakley Youth



- 62 Development Center shall provide gender-specific treatment for
- 63 youth who are adjudicated delinguent.
- 64 (3) Any portion of Columbia Training School property and
- 65 facilities described in Section 1 of Chapter 553, Laws of 2012,
- 66 may be conveyed or transferred to the Board of Supervisors of
- 67 Marion County, Mississippi.
- 68 (4) Any portion of Columbia Training School property and
- 69 facilities described in Section 2 of Chapter 386, Laws of 2017,
- 70 may be conveyed or transferred to the Marion County Economic
- 71 Development District for the purposes prescribed under that
- 72 section.
- FURTHER, amend the title by inserting the following after the semicolon on line 8:
- 75 TO AUTHORIZE THE DEPARTMENT OF FINANCE AND ADMINISTRATION TO
- 76 TRANSFER AND CONVEY CERTAIN REAL PROPERTY LOCATED AT COLUMBIA
- 77 TRAINING SCHOOL IN MARION COUNTY, MISSISSIPPI, TO THE MARION
- 78 COUNTY ECONOMIC DEVELOPMENT DISTRICT FOR THE PURPOSE OF PROVIDING
- 79 UNOBSTRUCTED ACCESS FOR THE INDUSTRIAL DEVELOPMENT OF THE MARION
- 80 COUNTY AIRPLEX; TO AMEND SECTION 43-27-39, MISSISSIPPI CODE OF
- 81 1972, TO CONFORM;
