HOUSE BILL NO. 1278

AN ACT TO PROVIDE THAT NO EMPLOYER SHALL PAY AN EMPLOYEE A 2 WAGE AT A RATE LESS THAN THE RATE AT WHICH AN EMPLOYEE OF THE OPPOSITE SEX IN THE SAME ESTABLISHMENT IS PAID FOR EQUAL WORK ON A JOB, THE PERFORMANCE OF WHICH REQUIRES EQUAL SKILL, EFFORT AND 5 RESPONSIBILITY, AND WHICH IS PERFORMED UNDER SIMILAR WORKING 6 CONDITIONS; TO PROVIDE THAT AN EMPLOYEE MAY FILE A PETITION IN THE 7 PROPER CIRCUIT COURT; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 **SECTION 1.** (1) No employer may pay an employee a wage at a 10 rate less than the rate at which an employee of the opposite sex 11 in the same establishment is paid for equal work on a job, the performance of which requires equal skill, effort and 12 13 responsibility, and which is performed under similar working 14 conditions, except where payment is made pursuant to a 15 differential based on: 16 (a) A seniority system; 17 (b) A merit system; 18 A system which measures earnings by quantity or quality of production; or 19

(d) Any factor other than sex.

- If an employer is found to have violated the provisions of subsection (1) of this section, the employee shall be awarded reasonable remedies as provided by federal law for violations of Ittle VII or Title IX.
