HOUSE CONCURRENT RESOLUTION NO. 36

A CONCURRENT RESOLUTION COMMENDING THE LEADERSHIP AND FORESIGHT OF LIEUTENANT COLONEL REUBEN SOLIZ, COMMANDER OF THE 379TH EXPEDITIONARY AEROMEDICAL EVACUATION SQUADRON, FOR EXEMPLARY AND MERITORIOUS RESPONSE TO ADVERSITY TO ENSURE THE SAFETY OF THOSE UNDER HIS COMMAND.

6 WHEREAS, every day, fearlessly brave Mississippians and 7 service members from around the nation who have taken the oath to uphold the United States Constitution and faithfully defend this 8 9 nation's borders and global principals of democracy and justice as 10 members of the United States Armed Forces, place their lives on the line for the assurance of our safety and protection; and 11 12 WHEREAS, Lieutenant Colonel Reuben Soliz, Commander of the 379th Expeditionary Aeromedical Evacuation Squadron, is one such 13 14 individual whose extraordinary leadership and selflessness above 15 and beyond the call of duty, was on full display during recent operations in support of Operation Inherent Resolve; and 16 17 WHEREAS, in response to the rising threat of total war with the nation of Iran resulting from incidents at the United States 18 19 Embassy in Baghdad and the termination of Major General Qasem

- 20 Soleimani, Lieutenant Colonel Soliz exhausted every possible
- 21 resource at his disposal, engaging the highest levels of United
- 22 States Air Forces Central Command (AFCENT) Wing Command, to ensure
- 23 the safe airlift of members of Aeromedical Evacuation Liaison Team
- 24 II, compromised of forces representing the Mississippi Air
- 25 National Guard, out of the forward threat area; and
- 26 WHEREAS, his steadfast dedication to the safety and
- 27 well-being of the men under his command led him to expeditiously
- 28 procure passage upon a Special Operations Command rotary-wing
- 29 asset, unknown to most forces, ensuring an expedient departure for
- 30 his personnel from a highly volatile location wherein conditions
- 31 were deteriorating quickly; and
- 32 WHEREAS, his unmatched intuition and resolve led to the
- 33 extraction and safety of the team under his command as well as
- 34 their ability to continue to carry out their mission in support of
- 35 the aeromedical evacuation of American military personnel in Iraq;
- 36 and
- 37 WHEREAS, it is the policy of this Legislature to recognize
- 38 and commend the selfless display of courage under fire, as
- 39 exemplified in the actions of Lieutenant Colonel Reuben Soliz,
- 40 whose experiences in encountering hostile attack allowed him to
- 41 gage the presence of a threat of imminent harm and respond with
- 42 expeditionary tactfulness to remove his squadron members from
- 43 harm:
