HOUSE CONCURRENT RESOLUTION NO. 79

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE 2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION, 3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO ESTABLISH 4 A COMMISSION TO REDESIGN THE MISSISSIPPI STATE FLAG; TO PRESCRIBE 5 THE MEMBERSHIP OF THE COMMISSION AND TO PROVIDE FOR ITS 6 ORGANIZATION AND MEETINGS; TO PROVIDE THAT THE DESIGN FOR THE 7 MISSISSIPPI STATE FLAG RECOMMENDED BY THE COMMISSION SHALL NOT INCLUDE THE DESIGN OF THE CONFEDERATE BATTLE FLAG BUT SHALL 8 INCLUDE THE WORDS "IN GOD WE TRUST"; TO PROVIDE THAT THE 9 COMMISSION SHALL MAKE ITS RECOMMENDATION FOR A DESIGN FOR THE NEW 10 MISSISSIPPI STATE FLAG BY SEPTEMBER 14, 2020; TO PROVIDE THAT THE 11 12 DESIGN FOR THE NEW MISSISSIPPI STATE FLAG RECOMMENDED BY THE 13 COMMISSION SHALL BE PLACED ON THE BALLOT IN A SPECIAL ELECTION TO BE HELD ON NOVEMBER 3, 2020; TO PROVIDE THAT IF A MAJORITY OF THE 14 15 QUALIFIED ELECTORS VOTE FOR THE NEW DESIGN, THEN THE LEGISLATURE 16 SHALL ENACT INTO LAW THE NEW DESIGN AS THE OFFICIAL MISSISSIPPI 17 STATE FLAG; TO PROVIDE THAT IF A MAJORITY OF THE QUALIFIED ELECTORS 18 VOTE AGAINST THE NEW DESIGN, THEN THE COMMISSION TO REDESIGN THE 19 MISSISSIPPI STATE FLAG SHALL RECONVENE TO RECOMMEND A NEW DESIGN FOR 20 THE MISSISSIPPI STATE FLAG TO BE PRESENTED TO THE LEGISLATURE DURING 21 THE 2021 REGULAR SESSION; TO REQUIRE THAT THE SPECIAL ELECTION BE 22 ADMINISTERED BY MEANS OF BALLOTS CONTAINING A COLOR PICTURE OR 23 DRAWING OF THE DESIGN FOR THE MISSISSIPPI STATE FLAG; TO REQUIRE 24 THE SECRETARY OF STATE TO PROVIDE THOSE BALLOTS TO THE ELECTION 25 COMMISSIONERS OF EACH COUNTY; TO AMEND SECTIONS 23-15-351 AND 26 23-15-355, MISSISSIPPI CODE OF 1972, TO CONFORM TO THE PRECEDING 27 PROVISIONS; TO REPEAL SECTION 3-3-16, MISSISSIPPI CODE OF 1972, 28 WHICH PROVIDES THE DESIGN FOR THE OFFICIAL FLAG OF THE STATE OF 29 MISSISSIPPI; AND FOR RELATED PURPOSES."

30 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE 31 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That all the

32 deadlines and other provisions imposed by Joint Rule No. 40 are 33 suspended for the purpose of requesting the drafting, and the 34 introduction, consideration and passage, of a bill entitled "AN 35 ACT TO ESTABLISH A COMMISSION TO REDESIGN THE MISSISSIPPI STATE 36 FLAG; TO PRESCRIBE THE MEMBERSHIP OF THE COMMISSION AND TO PROVIDE 37 FOR ITS ORGANIZATION AND MEETINGS; TO PROVIDE THAT THE DESIGN FOR THE MISSISSIPPI STATE FLAG RECOMMENDED BY THE COMMISSION SHALL NOT 38 39 INCLUDE THE DESIGN OF THE CONFEDERATE BATTLE FLAG BUT SHALL 40 INCLUDE THE WORDS "IN GOD WE TRUST"; TO PROVIDE THAT THE 41 COMMISSION SHALL MAKE ITS RECOMMENDATION FOR A DESIGN FOR THE NEW 42 MISSISSIPPI STATE FLAG BY SEPTEMBER 14, 2020; TO PROVIDE THAT THE 43 DESIGN FOR THE NEW MISSISSIPPI STATE FLAG RECOMMENDED BY THE 44 COMMISSION SHALL BE PLACED ON THE BALLOT IN A SPECIAL ELECTION TO BE 45 HELD ON NOVEMBER 3, 2020; TO PROVIDE THAT IF A MAJORITY OF THE 46 QUALIFIED ELECTORS VOTE FOR THE NEW DESIGN, THEN THE LEGISLATURE 47 SHALL ENACT INTO LAW THE NEW DESIGN AS THE OFFICIAL MISSISSIPPI 48 STATE FLAG; TO PROVIDE THAT IF A MAJORITY OF THE QUALIFIED ELECTORS 49 VOTE AGAINST THE NEW DESIGN, THEN THE COMMISSION TO REDESIGN THE 50 MISSISSIPPI STATE FLAG SHALL RECONVENE TO RECOMMEND A NEW DESIGN FOR 51 THE MISSISSIPPI STATE FLAG TO BE PRESENTED TO THE LEGISLATURE DURING 52 THE 2021 REGULAR SESSION; TO REQUIRE THAT THE SPECIAL ELECTION BE 53 ADMINISTERED BY MEANS OF BALLOTS CONTAINING A COLOR PICTURE OR 54 DRAWING OF THE DESIGN FOR THE MISSISSIPPI STATE FLAG; TO REQUIRE 55 THE SECRETARY OF STATE TO PROVIDE THOSE BALLOTS TO THE ELECTION 56 COMMISSIONERS OF EACH COUNTY; TO AMEND SECTIONS 23-15-351 AND
