- SECTION 1. Section 79-29-1021, Mississippi Code of 1972, is 6

- 79-29-1021. (1) The Secretary of State may commence a 8
- proceeding under Section 79-29-1023 to administratively revoke the 9
- 10 registration of a foreign limited liability company authorized to
- 11 transact business in this state if:
- 12 The foreign limited liability company does not pay
- within sixty (60) days after they are due any fees imposed by this 13
- 14 chapter or other law;
- 15 The foreign limited liability company does not
- deliver its annual report to the Secretary of State within sixty 16
- 17 (60) days after it is due;
- 18 The foreign limited liability company is without a
- registered agent in this state for sixty (60) days or more; 19

20	(d)	The	foreign	limited	liability	company	does	not

- 21 notify the Secretary of State within sixty (60) days that its
- 22 registered agent has been changed or that its registered agent has
- 23 resigned;
- 24 (e) The Secretary of State receives a duly
- 25 authenticated certificate from the Secretary of State or other
- 26 public official having custody of corporate records in the state
- 27 or country under whose law the foreign limited liability company
- 28 is organized stating that it has been dissolved or ceased to exist
- 29 as the result of a merger; * * \star
- 30 (f) The Department of Revenue notifies the Secretary of
- 31 State that the limited liability company is delinquent in any
- 32 payments or tax owed by the limited liability company to the State
- 33 of Mississippi; or
- 34 (* * *g) A misrepresentation has been made of any
- 35 material matter in any application, report, affidavit, or other
- 36 record submitted by the foreign limited liability company to the
- 37 Secretary of State pursuant to this chapter.
- 38 (2) The Secretary of State may not administratively revoke a
- 39 registration of a foreign limited liability company unless the
- 40 Secretary of State sends the foreign limited liability company
- 41 notice of the administrative revocation under Section 79-29-1023,
- 42 at least sixty (60) days before its effective date, by a record
- 43 addressed to its registered agent, or to the foreign limited
- 44 liability company if the foreign limited liability company fails

- 45 to appoint and maintain a proper agent in this state. The notice
- 46 must specify the cause for the administrative revocation of the
- 47 registration. The authority of the foreign limited liability
- 48 company to transact business in this state ceases on the effective
- 49 date of the administrative revocation unless the foreign limited
- 50 liability company cures the failure before that date.
