- 12 February 8, 2020. It was the Lady Commodores' Third State Title
- 13 overall; and
- 14 WHEREAS, "I'm so proud of the fact that the girls were able
- 15 to rise to the occasion," Lafayette Coach Melinda Scruggs said.
- 16 "We made a couple of adjustments at halftime and told the girls
- 17 they had to dig deep for 40 minutes and they did"; and
- 18 WHEREAS, Lafayette scored the first 10 minutes into the game
- 19 when Leslie Perkins scored off a pass from Hudson Lindsay to give

- 20 the Lady Commodores a 1-0 lead. East Central tied the game at 1-1 $\,$
- 21 ten minutes later on a shot by Alexis Cochran. In the second
- 22 half, Lafayette controlled possession of the ball and held East
- 23 Central to two shots on goal in the second half and three for the
- 24 entire game. When Johnson got the ball at the top of the 18-yard
- 25 mark, her pass got over the East Central goalkeeper's hands and
