House Amendments to Senate Bill No. 2929

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the support and
8	maintenance of the Alcorn State University Agricultural Programs
9	for the fiscal year beginning July 1, 2020, and ending
10	June 30, 2021\$ 6,380,081.00
11	SECTION 2. The following sum, or so much thereof as may be
12	necessary, is hereby authorized for expenditure out of any special
13	source funds which are collected by or otherwise become available,
14	for the support and maintenance of the Alcorn State University
15	Agricultural Programs for the fiscal year beginning July 1, 2020,
16	and ending June 30, 2021\$ 19,322.00
17	SECTION 3. Of the funds appropriated in Section 2, Nineteen
18	Thousand Three Hundred Twenty-two Dollars (\$19,322.00) shall be
19	derived from funds in the Education Enhancement Fund deposited
20	pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of

- 22 **SECTION 4.** No general funds authorized to be expended herein
- 23 shall be used to replace federal funds and/or other special funds
- 24 which are being used for salaries which are withdrawn and no
- 25 longer available.
- 26 **SECTION 5.** It is the intention of the Legislature that the
- 27 agency's budget request for Fiscal Year 2022 shall be submitted to
- 28 the Joint Legislative Budget Committee in a format and level of
- 29 detail comparable to the format and level of detail provided
- 30 during the Fiscal Year 2021 budget request process.
- 31 **SECTION 6.** It is the intention of the Legislature that
- 32 whenever two (2) or more bids are received by this agency for the
- 33 purchase of commodities or equipment, and whenever all things
- 34 stated in such received bids are equal with respect to price,
- 35 quality and service, the Mississippi Industries for the Blind
- 36 shall be given preference. A similar preference shall be given to
- 37 the Mississippi Industries for the Blind whenever purchases are
- 38 made without competitive bids.
- 39 **SECTION 7.** It is the intention of the Legislature that the
- 40 funds herein appropriated shall be expended in compliance with
- 41 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 42 shall incur obligations or indebtedness in excess of their
- 43 appropriation and that the responsible officers, either personally
- 44 or upon their official bonds, shall be held responsible for
- 45 actions contrary to this provision.

SECTION 8. Of the funds appropriated in Section 1, One
Hundred Eighty-five Thousand Dollars (\$185,000.00) is provided for
the Aquaculture Research Facility.

49 The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 50 51 credit of the proper fund or funds as set forth in this act, upon 52 warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the 53 54 proper person, officer or officers in the manner provided by law. 55 SECTION 10. This act shall take effect and be in force from and after July 1, 2020, and shall stand repealed from and after 56 June 30, 2020. 57
