House Amendments to Senate Bill No. 2939

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the purpose of
8	defraying the general expenses of the operation of the Mississippi
9	National Guard for the fiscal year beginning July 1, 2020, and
10	ending June 30, 2021\$ 7,995,784.00.
11	SECTION 2. The following sum, or so much thereof as may be
12	necessary, is hereby appropriated to the Mississippi National
13	Guard, out of any money in the State Treasury to the credit of the
14	Camp Shelby Timber Fund No. 3700, as created by Chapter 187, Laws
15	of 1954, as amended; the Army National Guard Programs Fund No.
16	3701; the Camp Shelby Base Operations Fund No. 3705; and the Air
17	National Guard Programs Fund No. 3709, for the purpose of carrying
18	out the provisions of applicable statutes and federal/state
19	agreements for the fiscal year beginning July 1, 2020, and ending
20	June 30, 2021\$ 123,589,094.00.

- 21 **SECTION 3.** Of the funds appropriated under the provisions of
- 22 this act, the following positions are authorized:
- 23 AUTHORIZED POSITIONS:
- Permanent: Full Time..... 875
- 25 Part Time..... 0
- 26 Time-Limited: Full Time..... 26
- 27 Part Time..... 0
- 28 Any transfers or escalations shall be made in accordance with
- 29 the terms, conditions, and procedures established by law.
- No general funds authorized to be expended herein shall be
- 31 used to replace federal funds and/or other special funds which are
- 32 being used for salaries authorized under the provisions of this
- 33 act and which are withdrawn and no longer available.
- 34 **SECTION 4.** The Adjutant General of Mississippi is hereby
- 35 authorized to transfer any part of appropriated funds, including
- 36 general funds, to special funds, within the Mississippi Military
- 37 Department including, but not limited to, funds to facilitate
- 38 federal grant matching requirements. Prior written notification
- 39 of transfer shall be provided to the Legislative Budget Office,
- 40 and the Department of Finance and Administration.
- 41 **SECTION 5.** It is the intention of the Legislature that the
- 42 agency's budget request for Fiscal Year 2022 shall be submitted to
- 43 the Joint Legislative Budget Committee in a format and level of
- 44 detail comparable to the format and level of detail provided
- 45 during the Fiscal Year 2021 budget request process.

- 46 **SECTION 6.** All funds authorized to be expended herein shall
- 47 be expended and otherwise accounted for in accordance with the
- 48 provisions of Section 27-104-1 et seq., Mississippi Code of 1972.
- 49 If not needed for other purposes, the Adjutant General is hereby
- 50 expressly authorized to invest any part of or all monies herein
- 51 appropriated out of the Camp Shelby Timber Fund at the highest
- 52 rate of interest obtainable and credit interest accruing on such
- 53 investments to the respective fund. Such monies may be invested
- 54 in any short-term bonds, notes or other direct obligations of the
- 55 United States of America or the State of Mississippi or any county
- or municipality of this state, which said county or municipal
- 57 bonds have been approved by a reputable bonds attorney or have
- 58 been validated by a decree of the court, and in any event the said
- 59 bonds, notes or obligations in which such funds are invested shall
- 60 mature or be redeemable prior to the time the funds so invested
- 61 will be needed for the refund or refunds herein provided for.
- 62 **SECTION 7.** Of the funds appropriated in Section 1, One
- 63 Million Nine Hundred Twenty-eight Thousand Seventy-five Dollars
- 64 (\$1,928,075.00) shall be provided for the support of the Youth
- 65 Challenge Program at Camp Shelby.
- 66 **SECTION 8.** Of the funds provided under the provisions of
- 67 this act, Six Hundred Twenty-six Thousand Five Hundred Five
- Dollars (\$626,505.00) is provided for the Armed Forces Military
- 69 Museum located at Camp Shelby.
- 70 **SECTION 9.** Of the funds appropriated to be expended in this
- 71 act, no General Funds shall be used to reimburse members and

- 72 personnel of the Mississippi National Guard for the costs
- 73 associated with attending authorized training. Any expenditure of
- 74 funds for the purpose of compensation of such personnel and
- 75 members for per diems and travel expenses shall be expended from
- 76 any federal funds which are made available to the Mississippi
- 77 National Guard for ancillary purposes.
- 78 **SECTION 10.** Of the funds provided under the provisions of
- 79 this act, an amount not to exceed Three Hundred Thousand Dollars
- 80 (\$300,000.00) is provided for the Sonny Montgomery Center for
- 81 America's Veterans at Mississippi State University.
- 82 **SECTION 11.** Of the funds provided in Sections 1 and 2, Ten
- 83 Thousand Dollars (\$10,000.00) is provided for the purchase of
- 84 uniforms for the Youth Challenge Program staff.
- 85 **SECTION 12.** It is the intention of the Legislature that
- 86 whenever two (2) or more bids are received by this agency for the
- 87 purchase of commodities or equipment, and whenever all things
- 88 stated in such received bids are equal with respect to price,
- 89 quality and service, the Mississippi Industries for the Blind
- 90 shall be given preference. A similar preference shall be given to
- 91 the Mississippi Industries for the Blind whenever purchases are
- 92 made without competitive bids.
- 93 **SECTION 13.** It is the intention of the Legislature that the
- 94 funds herein appropriated shall be expended in compliance with
- 95 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 96 shall incur obligations or indebtedness in excess of their
- 97 appropriation and that the responsible officers, either personally

- or upon their official bonds, shall be held responsible for actions contrary to this provision.
- 100 SECTION 14. The money herein appropriated shall be paid by 101 the State Treasurer out of any money in the State Treasury to the 102 credit of the proper fund or funds as set forth in this act, upon 103 warrants issued by the State Fiscal Officer; and the State Fiscal 104 Officer shall issue his warrants upon requisitions signed by the 105 proper person, officer or officers, in the manner provided by law. 106 SECTION 15. This act shall take effect and be in force from 107 and after July 1, 2020, and shall stand repealed from and after
