## House Amendments to Senate Bill No. 2975

## TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

## AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 22 unless programs or positions are added to the agency's Fiscal Year
- 23 2021 budget by the Mississippi Legislature. Based on data
- 24 provided by the Legislative Budget Office, the State Personnel
- 25 Board shall determine and publish the projected annual cost to
- 26 fully fund all appropriated positions in compliance with the
- 27 provisions of this act. It shall be the responsibility of the
- 28 agency head to ensure that no single personnel action increases
- 29 this projected annual cost and/or the Fiscal Year 2021
- 30 appropriations for "Personal Services" when annualized, with the

- 68 due for prepaid tuition contracts of the Mississippi Prepaid

- 70 July 1, 2020, and ending June 30, 2021...... \$ 35,000,000.00.
- 71 It is the intention of the Legislature that the State
- 72 Treasurer is hereby authorized to accept, budget and expend an

- 73 amount not to exceed One Million Dollars (\$1,000,000.00) from any
- 74 funds authorized for the Mississippi Prepaid Affordable College
- 75 Tuition Program, for paying amounts due for prepaid tuition

the State Treasurer out of any money in the State Treasury to the
credit of the proper fund or funds as set forth in this act, upon
warrants issued by the State Fiscal Officer; and the State Fiscal
Officer shall issue his warrants upon requisitions signed by the

SECTION 10. This act shall take effect and be in force from and after July 1, 2020, and shall stand repealed from and after June 30, 2020.
