AMENDMENT NO 1 PROPOSED TO**

House Bill No. 265

BY: Representative Read

**Amend by striking all after the enacting clause and inserting
in lieu thereof the following:**

18 **SECTION 1.** Section 25-3-31, Mississippi Code of 1972, is
19 amended as follows:

20 25-3-31. (1) The annual salary of the Governor shall be One
21 Hundred Twenty-two Thousand One Hundred Sixty Dollars
22 (\$122,160.00).

23 (2) The annual salaries of the following elected state and
24 district officers are fixed as follows through June 30, 2021:

25 * * *Attorney General.....	108,960.00
26 Secretary of State.....	90,000.00
27 Commissioner of Insurance.....	90,000.00



28	State Treasurer.....	90,000.00
29	State Auditor of Public Accounts.....	90,000.00
30	Commissioner of Agriculture and Commerce.....	90,000.00
31	Transportation Commissioners.....	78,000.00

34 (3) From and after July 1, 2021, the annual salaries of the
35 officers listed in subsection (2) of this section shall be the
36 amounts appropriated for each of those officers by the
37 Legislature, subject to the following limitations:

38 The amount of the annual salary for any of those officers
39 appropriated by the Legislature for fiscal year 2022 shall not be
40 less than the annual salary amount specified for that officer in
41 subsection (2) or more than three percent (3%) above the annual
42 salary amount specified for that officer in subsection (2). For
43 each of the next two (2) fiscal years, the Legislature may
44 increase the amount of the annual salary for any of those officers
45 by not more than three percent (3%) above the annual salary amount
46 appropriated for the preceding fiscal year. However, the annual
47 salary appropriated for any of those officers shall not be more
48 than the amount of the annual salary of the Governor.

49 **SECTION 2.** This act shall take effect and be in force from
50 and after its passage.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**



1 AN ACT TO AMEND SECTION 25-3-31, MISSISSIPPI CODE OF 1972, TO
2 PROVIDE THAT FROM AND AFTER JULY 1, 2021, THE ANNUAL SALARIES OF
3 THE ELECTED STATE OFFICERS OTHER THAN THE GOVERNOR SHALL BE THE
4 AMOUNTS APPROPRIATED FOR EACH OF THOSE OFFICERS BY THE
5 LEGISLATURE, SUBJECT TO CERTAIN LIMITATIONS; TO PROVIDE THAT THE
6 AMOUNT OF THE ANNUAL SALARY FOR ANY OF THOSE OFFICERS APPROPRIATED
7 BY THE LEGISLATURE FOR FISCAL YEAR 2022 SHALL NOT BE LESS THAN THE
8 CURRENT AMOUNT FOR THAT OFFICER OR MORE THAN THREE PERCENT ABOVE
9 THE CURRENT AMOUNT FOR THAT OFFICER; TO PROVIDE THAT FOR EACH OF
10 THE NEXT TWO FISCAL YEARS, THE LEGISLATURE MAY INCREASE THE AMOUNT
11 OF THE ANNUAL SALARY FOR ANY OF THOSE OFFICERS BY NOT MORE THAN
12 THREE PERCENT ABOVE THE ANNUAL SALARY AMOUNT APPROPRIATED FOR THE
13 PRECEDING FISCAL YEAR; TO PROVIDE THAT THE ANNUAL SALARY
14 APPROPRIATED FOR ANY OF THOSE OFFICERS SHALL NOT BE MORE THAN THE
15 AMOUNT OF THE ANNUAL SALARY OF THE GOVERNOR; AND FOR RELATED
16 PURPOSES.
