Senate Amendments to House Bill No. 415

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 9 **SECTION 1.** Section 25-3-3, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 25-3-3. (1) The term "total assessed valuation" as used in
- 12 this section only refers to the ad valorem assessment for the
- 13 county and, in addition, in counties where oil or gas is produced,
- 14 the actual value of oil at the point of production, as certified
- 15 to the counties by the Department of Revenue under the provisions
- of Sections 27-25-501 through 27-25-525, and the actual value of
- 17 gas as certified by the Department of Revenue under the provisions
- 18 of Sections 27-25-701 through 27-25-723.
- 19 (2) The salary of assessors and collectors of the various
- 20 counties is fixed as full compensation for their services as
- 21 county assessors or tax collectors, or both if the office of
- 22 assessor has been combined with the office of tax collector. The
- 23 annual salary of each assessor or tax collector, or both if the
- 24 offices have been combined, shall be based upon the total assessed

- 25 valuation of his respective county for the preceding taxable year
- 26 in the following categories and for the following amounts:
- 27 (a) For counties having a total assessed valuation of
- 28 Three Billion Dollars (\$3,000,000,000.00) or more, a salary of
- 29 Seventy Thousand Five Hundred Sixty Dollars (\$70,560.00);
- 30 (b) For counties having a total assessed valuation of
- 31 at least Two Billion Dollars (\$2,000,000,000.00) but less than
- 32 Three Billion Dollars (\$3,000,000,000.00), a salary of Sixty-seven
- 33 Thousand Two Hundred Dollars (\$67,200.00);
- 34 (c) For counties having a total assessed valuation of
- 35 at least One Billion Dollars (\$1,000,000.00) but less than Two
- 36 Billion Dollars (\$2,000,000,000.00), a salary of Sixty-four
- 37 Thousand Five Hundred Seventy-five Dollars (\$64,575.00);
- 38 (d) For counties having a total assessed valuation of
- 39 at least Five Hundred Million Dollars (\$500,000,000.00) but less
- 40 than One Billion Dollars (\$1,000,000,000.00), a salary of
- 41 Sixty-one Thousand Four Hundred Twenty-five Dollars (\$61,425.00);
- 42 (e) For counties having a total assessed valuation of
- 43 at least Two Hundred Fifty Million Dollars (\$250,000,000.00) but
- 44 less than Five Hundred Million Dollars (\$500,000,000.00), a salary
- of Fifty-eight Thousand Eight Hundred Dollars (\$58,800.00);
- 46 (f) For counties having a total assessed valuation of
- 47 at least One Hundred Fifty Million Dollars (\$150,000,000.00) but
- 48 less than Two Hundred Fifty Million Dollars (\$250,000,000.00), a
- 49 salary of Fifty-six Thousand Seven Hundred Dollars (\$56,700.00);

50 (g) For counties having a total assessed valuation of

51 at least Seventy-five Million Dollars (\$75,000,000.00) but less

52 than One Hundred Fifty Million Dollars (\$150,000,000.00), a salary

of Fifty-five Thousand One Hundred Twenty-five Dollars

(h) For counties having a total assessed valuation of

less than Seventy-five Million Dollars (\$75,000,000.00), a salary

of Fifty Thousand Nine Hundred Twenty-nine Dollars (\$50,929.00).

58 (3) In addition to all other compensation paid pursuant to

59 this section, the board of supervisors shall pay to a person

60 serving as both the tax assessor and tax collector in their county

an additional Five Thousand Dollars (\$5,000.00) per year.

62 (4) The annual salary established for assessors and tax

63 collectors shall not be reduced as a result of a reduction in

total assessed valuation. The salaries shall be increased as a

65 result of an increase in total assessed valuation.

66 (5) In addition to all other compensation paid to assessors

and tax collectors in counties having two (2) judicial districts,

68 the board of supervisors shall pay such assessors and tax

69 collectors an additional Three Thousand Five Hundred Dollars

70 (\$3,500.00) per year. In addition to all other compensation paid

71 to assessors or tax collectors, in counties maintaining two (2)

72 full-time offices, the board of supervisors shall pay the assessor

73 or tax collector an additional Three Thousand Five Hundred Dollars

 $74 \quad (\$3,500.00) \text{ per year.}$

In addition to all other compensation paid to assessors and tax collectors, the board of supervisors of a county shall allow for such assessor or tax collector, or both, to be paid additional compensation when there is a contract between the county and one or more municipalities providing that the assessor or tax collector, or both, shall assess or collect taxes, or both, for the municipality or municipalities; and such assessor or tax collector, or both, shall be authorized to receive such additional compensation from the county and/or the municipality or municipalities in any amount allowed by the county and/or the municipality or municipalities for performing those services.

(7) When any tax assessor holds a valid certificate of educational recognition from the International Association of Assessing Officers or is a licensed appraiser under Section 73-34-1 et seq., he shall receive an additional One Thousand Five Hundred Dollars (\$1,500.00) annually beginning the next fiscal year after completion. When any tax assessor is a licensed state certified Residential Appraiser (RA) or licensed state certified Timberland Appraiser (TA) under Section 73-34-1 et seq., or when any tax assessor holds a valid designation from the International Association of Assessing Officers as a Cadastral Mapping Specialist (CMS) or Personal Property Specialist (PPS) or Residential Evaluation Specialist (RES), he shall receive an additional Six Thousand Five Hundred Dollars (\$6,500.00) annually beginning the next fiscal year after completion. When any tax assessor holds the valid designation of Certified Assessment

- 101 Evaluator (CAE) from the International Association of Assessing
- 102 Officers or is a state certified General Real Estate Appraiser
- 103 (GA) under Section 73-34-1 et seq., he shall receive an additional
- 104 Eight Thousand Five Hundred Dollars (\$8,500.00) annually beginning
- 105 the next fiscal year after completion.
- 106 (8) The salaries provided for in this section shall be the
- 107 total funds paid to the county assessors and tax collectors and
- 108 shall be full compensation for their services, with any fees being
- 109 paid to the county general fund.
- 110 (9) The salaries provided for in this section shall be
- 111 payable monthly on the first day of each calendar month by
- 112 chancery clerk's warrant drawn on the general fund of the county;
- 113 however, the board of supervisors, by resolution duly adopted and
- 114 entered on its minutes, may provide that such salaries shall be
- 115 paid semimonthly on the first and fifteenth day of each month or
- 116 every two (2) weeks pursuant to Section 25-3-29. If a pay date
- 117 falls on a weekend or legal holiday, salary payments shall be made
- 118 on the workday immediately preceding the weekend or legal holiday.
- SECTION 2. Section 25-3-17, Mississippi Code of 1972, is
- 120 amended as follows:
- 121 25-3-17. The salaries provided in Sections 25-3-13 and
- 122 25-3-15 shall be payable monthly on the first day of each calendar
- 123 month during the calendar year following that in which the total
- 124 assessed valuation is determined; however, the board of
- 125 supervisors, by resolution duly adopted and entered on its
- 126 minutes, may provide that such salaries shall be paid semimonthly

- on the first and fifteenth day of each month or every two (2)
- 128 weeks pursuant to Section 25-3-29. If a pay date falls on a
- 129 weekend or legal holiday, salary payments shall be made on the
- 130 workday immediately preceding the weekend or legal holiday. The
- 131 chancery clerk shall draw his warrant on the general fund of the
- 132 county, the county road and bridge fund, or any fund of the county
- 133 available for such purposes.
- SECTION 3. Section 25-3-19, Mississippi Code of 1972, is
- 135 amended as follows:
- 136 25-3-19. The chancery clerks, as county auditors, shall
- 137 receive compensation for their services as such the annual amount
- 138 of Five Thousand Three Hundred Dollars (\$5,300.00), payable in
- 139 equal monthly installments out of the county treasury; however,
- 140 the board of supervisors, by resolution duly adopted and entered
- 141 on its minutes, may provide that such salaries shall be paid
- 142 semimonthly on the first and fifteenth day of each month or every
- 143 two (2) weeks pursuant to Section 25-3-29. If a pay date falls on
- 144 a weekend or legal holiday, salary payments shall be made on the
- 145 workday immediately preceding the weekend or legal holiday.
- SECTION 4. Section 25-3-29, Mississippi Code of 1972, is
- 147 amended as follows:
- 148 25-3-29. Except as otherwise therein provided, the salaries
- 149 mentioned in the foregoing sections shall be paid monthly out of
- 150 the general county fund, and the \star \star salaries and allowances
- 151 shall be included in the budget of each county; however, the board
- 152 of supervisors, by resolution duly adopted and entered on its

- 153 minutes, may provide that such salaries shall be paid semimonthly
- on the first and fifteenth day of each month or every two (2)
- 155 weeks. If a pay date falls on a weekend or legal holiday, salary
- 156 payments shall be made on the workday immediately preceding the
- 157 weekend or legal holiday.
- 158 **SECTION 5.** Section 25-3-36, Mississippi Code of 1972, is
- 159 amended as follows:
- 160 25-3-36. (1) Until October 1, 2008, every justice court
- 161 judge shall receive as full compensation for his or her services,
- 162 and in lieu of any and all other fees, costs or compensation
- 163 heretofore authorized for such justice court judge, an annual
- 164 salary based upon the population of his or her county according to
- 165 the latest federal decennial census; however, no justice court
- 166 judge shall be paid less than the salary authorized under this
- 167 section to be paid the justice court judge based upon the
- 168 population of the county according to the 1980 federal decennial
- 169 census. The amount of which salary shall be determined as
- 170 follows:
- 171 (a) In counties with a population of more than two
- 172 hundred thousand (200,000), a salary of Fifty-five Thousand Five
- 173 Hundred Fifty-nine Dollars (\$55,559.00).
- 174 (b) In counties with a population of more than one
- 175 hundred fifty thousand (150,000) but not more than two hundred
- 176 thousand (200,000), a salary of Fifty-one Thousand Five Dollars
- 177 (\$51,005.00).

- 178 (c) In counties with a population of more than
- 179 seventy-five thousand (75,000) but not more than one hundred fifty
- 180 thousand (150,000), a salary of Forty-six Thousand Four Hundred
- 181 Fifty-one Dollars (\$46,451.00).
- 182 (d) In counties with a population of more than
- 183 forty-nine thousand (49,000) but not more than seventy-five
- thousand (75,000), a salary of Forty Thousand Seventy-five Dollars
- 185 (\$40,075.00).
- 186 (e) In counties with a population of more than
- 187 thirty-four thousand (34,000) but not more than forty-nine
- 188 thousand (49,000), a salary of Thirty-four Thousand Six Hundred
- 189 Ten Dollars (\$34,610.00).
- 190 (f) In counties with a population of more than
- 191 twenty-four thousand five hundred (24,500) but not more than
- 192 thirty-four thousand (34,000), a salary of Thirty-two Thousand
- 193 Seven Hundred Eighty-nine Dollars (\$32,789.00).
- 194 (q) In counties with a population of more than
- 195 twenty-one thousand (21,000) but not more than twenty-four
- 196 thousand five hundred (24,500), a salary of Twenty-nine Thousand
- 197 One Hundred Forty-six Dollars (\$29,146.00).
- 198 (h) In counties with a population of more than sixteen
- 199 thousand five hundred (16,500) but not more than twenty-one
- 200 thousand (21,000), a salary of Twenty-five Thousand Five Hundred
- 201 Two Dollars (\$25,502.00).
- 202 (i) In counties with a population of more than twelve
- 203 thousand (12,000) but not more than sixteen thousand five hundred

- 204 (16,500), a salary of Twenty-one Thousand Eight Hundred Fifty-nine
- 205 Dollars (\$21,859.00).
- 206 (j) In counties with a population of more than eight
- 207 thousand (8,000) but not more than twelve thousand (12,000), a
- 208 salary of Eighteen Thousand Dollars (\$18,000.00).
- (k) In counties with a population of eight thousand
- 210 (8,000) or less, a salary of Fourteen Thousand Four Hundred
- 211 Dollars (\$14,400.00).
- The board of supervisors of any county having two (2)
- 213 judicial districts and two (2) justice court judges for the county
- 214 shall pay each justice court judge an amount equal to that
- 215 provided in this subsection for judges in the next higher
- 216 population category per year, if the justice court judge maintains
- 217 regular office hours and is personally present in the office they
- 218 maintain for at least thirty (30) hours per week.
- In any county having a population greater than eight thousand
- 220 (8,000) but less than eight thousand five hundred (8,500)
- 221 according to the 1990 federal decennial census and in which U.S.
- 222 Highway 61 and Mississippi Highway 4 intersect, the board of
- 223 supervisors, in its discretion, may pay such justice court judges
- 224 an additional amount not to exceed the sum of Eleven Thousand Five
- 225 Hundred Fifty Dollars (\$11,550.00) per year, payable beginning
- 226 April 1, 1997.
- In any county having a population greater than ten thousand
- 228 (10,000) but less than ten thousand five hundred (10,500)
- 229 according to the 1990 federal decennial census and in which

- 230 Mississippi Highway 3 and Mississippi Highway 6 intersect, the
- 231 board of supervisors, in its discretion, may pay such justice
- 232 court judges an additional amount not to exceed One Thousand Four
- 233 Hundred Fifty Dollars (\$1,450.00) per year, payable beginning
- 234 April 1, 1997.
- In any county having a population greater than twenty-four
- 236 thousand seven hundred (24,700) and less than twenty-four thousand
- 237 nine hundred (24,900), according to the 1990 federal census,
- 238 wherein Mississippi Highways 15 and 16 intersect, the board of
- 239 supervisors shall pay such justice court judge an additional
- 240 amount equal to Two Thousand Five Hundred Dollars (\$2,500.00) per
- 241 year.
- 242 (2) From and after October 1, 2008, every justice court
- 243 judge shall receive as full compensation for his or her services,
- 244 and in lieu of any and all other fees, costs or compensation
- 245 heretofore authorized for such justice court judge, an annual
- 246 salary in an amount that is the greater of the following:
- 247 (a) The amount paid to a member of the board of
- 248 supervisors in the same county in which the justice court judge
- 249 presides; or
- 250 (b) One hundred three percent (103%) of the salary
- 251 authorized under this section as of September 30, 2008, for a
- 252 justice court judge in that county.
- 253 If supervisors of a county receive a salary increase, justice
- 254 court judges whose salary is determined under this paragraph shall
- 255 be paid an amount reflecting a commensurate increase.

- 256 Notwithstanding the provisions of subsection (1) of this 257 section, in the event that the number of justice court judges 258 authorized pursuant to Section 9-11-2(1) is exceeded pursuant to 259 the provisions of Section 9-11-2(4), the aggregate of the salaries 260 paid to the justice court judges of such a county shall not exceed 261 the amount sufficient to pay the number of justice court judges 262 authorized pursuant to Section 9-11-2(1), and such amount shall be equally divided among those justice court judges continuing to 263 264 hold office under the provisions of Section 9-11-2(4).
 - From and after January 1, 1984, all fees, costs, fines and penalties charged and collected in the justice court shall be paid to the clerk of the justice court for deposit, along with monies from cash bonds and other monies which have been forfeited in criminal cases, into the general fund of the county as provided in Section 9-11-19; and the clerk of the board of supervisors shall be authorized and empowered, upon approval by the board of supervisors, to make disbursements and withdrawals from the general fund of the county in order to pay any reasonable and necessary expenses incurred in complying with this section, including payment of the salaries of justice court judges as provided by subsection (1) of this section. The provisions of this subsection shall not, except as to cash bonds and other monies which have been forfeited in criminal cases, apply to monies required to be deposited in the justice court clerk clearing account as provided in Section 9-11-18, Mississippi Code of 1972.

- 282 The salaries provided for in this section shall be 283 payable monthly by warrant drawn by the clerk of the board of supervisors on the general fund of the county; however, the board 284 285 of supervisors, by resolution duly adopted and entered on its 286 minutes, may provide that such salaries shall be paid semimonthly 287 on the first and fifteenth day of each month or every two (2) 288 weeks pursuant to Section 25-3-29. If a pay date falls on a 289 weekend or legal holiday, salary payments shall be made on the 290 workday immediately preceding the weekend or legal holiday.
- 291 (6) Provided, that the salary of any justice court judge 292 shall not be reduced during his term of office as a result of a 293 population change following a federal decennial census.
- (7) Any justice court judge who is unable to attend and hold court by reason of being under suspension by the Commission on Judicial Performance or the Mississippi Supreme Court shall not receive a salary while under such suspension.
- 298 **SECTION 6.** This act shall take effect and be in force from 299 and after its passage.
