## HOUSE BILL NO. 213

- 1 AN ACT TO AMEND SECTION 31-9-13, MISSISSIPPI CODE OF 1972, TO 2 AUTHORIZE THE DEPARTMENT OF ADMINISTRATION, OFFICE OF SURPLUS 3 PROPERTY TO ADMINISTER THE FEDERAL DONATION PROGRAM, AND COLLECT FEES AND ASSESSMENTS FROM ENTITIES RECEIVING SURPLUS PROPERTY FOR 5 THE PURPOSE OF MAINTAINING A REVOLVING FUND IN ACCORDANCE WITH 6 PROCEDURES OUTLINED BY THE UNITED STATES GENERAL SERVICES 7 ADMINISTRATION; AND FOR RELATED PURPOSES.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 31-9-13, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 31-9-13. In lieu of regular appropriations, the Department
- 12 of Finance and Administration may assess against each institution,
- 13 agency or individual acquiring surplus property from and through
- 14 the Department of Finance and Administration a fee or commission
- 15 on each item in sufficient amount to establish and maintain a
- 16 revolving fund, to be used to operate and support the Department
- of Finance and Administration, Office of Surplus Property's 17
- 18 Federal Donation program. The Department of Finance and
- Administration shall follow the procedure outlined by the United 19
- 20 States \* \* \* General Service Administration in establishing the

- 21 fund, and the fund shall never exceed more than One Million
- Dollars (\$1,000,000.00) above and beyond four (4) months of
- 23 operating expenses of the Department of Finance and
- 24 Administration.
- 25 With this revolving fund so acquired, the Department of
- 26 Finance and Administration shall meet all items of expense
- 27 incurred in acquiring, transporting, warehousing and distributing
- 28 property to eligible applicants and also all items of expense
- 29 incident to the operation of the offices of the Department of
- 30 Finance and Administration, including salaries, office supplies
- 31 and necessary general expenses, and all other items as are covered
- 32 by legislative appropriation for those purposes.
- 33 The Department of Finance and Administration may escalate,
- 34 budget and expend funds from the revolving fund in an amount not
- 35 to exceed Two Hundred Fifty Thousand Dollars (\$250,000.00) in any
- 36 one fiscal year to carry out the provisions of this section.
- 37 **SECTION 2.** This act shall take effect and be in force from
- 38 and after its passage.
