## HOUSE BILL NO. 302

AN ACT TO AMEND SECTIONS 37-179-1 AND 37-179-3, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE STATE BOARD OF EDUCATION TO APPROVE THE CREATION OF DISTRICTS OF INNOVATION; TO DEFINE CERTAIN TERMS RELATED TO "DISTRICTS OF INNOVATION"; TO LIMIT THE INITIAL 5 APPROVAL AND SUBSEQUENT RENEWALS OF DISTRICTS OF INNOVATION TO 6 FIVE-YEAR PERIODS; TO DIRECT THE BOARD TO PROMULGATE 7 ADMINISTRATIVE RULES AND REGULATIONS TO PRESCRIBE THE CONDITIONS AND PROCEDURES TO BE USED BY LOCAL SCHOOL BOARDS TO BE APPROVED AS 8 9 A DISTRICT OF INNOVATION; TO SPECIFY THE CRITERIA TO BE ADDRESSED 10 BY THE ADMINISTRATIVE REGULATIONS; TO PRESCRIBE THE REQUIREMENTS FOR A DISTRICT TO BE A DISTRICT OF INNOVATION APPLICANT; TO 11 12 PRESCRIBE THE STATUTORY REQUIREMENTS WITH WHICH SCHOOLS OF 13 INNOVATION WITHIN DISTRICTS OF INNOVATION MUST COMPLY; TO IDENTIFY AREAS IN WHICH DISTRICTS OF INNOVATION MAY REQUEST APPROVAL OF 14 1.5 PRACTICES THAT ARE DIFFERENT THAN CURRENT STATUTORY REQUIREMENTS; 16 AND FOR RELATED PURPOSES. 17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 18 SECTION 1. Section 37-179-1, Mississippi Code of 1972, is 19 amended as follows: 20 37-179-1. (1) For purposes of this chapter, the following terms shall have the meaning ascribed herein, unless the context 21 clearly indicates otherwise: 22 23 (a) "District of innovation" means a district that has 24 developed a plan of innovation in compliance with this section and

has been approved by the State Board of Education to be exempted

- 29 (b) "Innovation" means a new or creative alternative to
- 30 existing instructional and administrative practices intended to
- 31 improve student learning and student performance of all students,
- 32 including community schools;
- 33 (c) "School of innovation" means a school that
- 34 voluntarily participates in a district of innovation plan to
- 35 improve instruction, including waivers and exemptions from local
- 36 school board policies, selected provisions of rules and
- 37 regulations promulgated by the State Board of Education, and
- 38 selected sections of the Mississippi Code of 1972, as permitted
- 39 under this section and Section \* \* \* 37-179-3;
- 40 (d) "Board" means the State Board of Education;
- 41 (e) "Department" means the State Department of
- 42 Education.
- 43 (f) "Community school" means a traditional district
- 44 public school that partners with community-based organizations to
- 45 coordinate academic, social, physical health and mental health
- 46 services, to reduce barriers to learning and improve education
- 47 outcomes. Community schools include all five (5) of the
- 48 following:

49	(i) Integrated student supports coordinated by a
50	community school director, which may include, but are not limited
51	<u>to:</u>
52	1. Medical, dental, vision care and mental
53	health services; or
54	2. Counselors to assist with housing,
55	transportation, nutrition, or criminal justice issues;
56	(ii) Expanded and enriched learning time and
57	opportunities including before school, after school, weekend and
58	summer programs, which provide additional academic instruction,
59	individualized academic support, enrichment activities, and
60	learning opportunities that emphasize real-world learning and
61	community problem solving, and which may include, but are not
62	<pre>limited to:</pre>
63	1. Art, music, drama and creative writing;
64	2. Hands-on experience with engineering or
65	science;
66	3. Tutoring and homework help; and
67	4. Recreational programs that enhance and are
68	<pre>consistent with the school's curriculum;</pre>
69	(iii) Active family and community engagement which
70	brings students' families and the community into the school as
71	partners in children's education and makes the school a
72	neighborhood hub, providing adults with educational opportunities
73	they want, including, but not limited to:

74	1. English as a second language class;
75	2. Citizenship preparation;
76	3. Computer skills;
77	<u>4. Art;</u>
78	5. GED classes; or
79	6. Other programs that bring community
80	members into the building for meetings or events;
81	(iv) Include, as a meaningful part of its
82	curriculum, a Science, Technology, Engineering and Mathematics
83	(STEM) program component commensurate and appropriate to the grade
84	level of the school; and
85	(v) Collaborative leadership and practices, which
86	build a culture of professional learning, collective trust, and
87	shared responsibility using strategies which shall, at a minimum,
88	<pre>include:</pre>
89	1. A school-based leadership team;
90	2. A community school director; and
91	3. A community-wide leadership team, which
92	may include, but not limited to:
93	A. Other leadership and governance
94	teams;
95	B. Teacher learning communities; and
96	C. Other staff to manage the multiple,
97	complex, joint work of school and community organizations.
98	(g) "Community School Director" means a person who:

99	(i) Is a full-time staff member serving one (1)
100	eligible school;
101	(ii) Is responsible for the identification,
102	implementation and coordination of integrated student supports,
103	expanded and enriched learning time and opportunities, family and
104	community engagement and collaborative leadership and practices;
105	(iii) Serves as a member of the school-based
106	<pre>leadership team;</pre>
107	(iv) Serves as the lead for the needs and assets
108	assessment and community school plan; and
109	(v) Coordinates the needs and assets assessment
110	and stakeholder-driven approach to problem-solving and continuous
111	<pre>improvement.</pre>
112	(2) The State Board of Education is authorized to approve
113	districts of innovation for the purposes of improving students'
114	educational performance. Districts of innovation shall be
115	provided flexibility from selected board regulations, Title 37,
116	Mississippi Code of 1972, and local school board policies for
117	school administrators, teachers and staff to meet the diverse
118	needs of students. A low-performing school or school district
119	managing the transition of multiple schools to the community
120	school model shall be provided a three-year transition before
121	becoming eligible for state takeover. The initial approval of a
122	district of innovation shall be for a five-year period. Each
123	renewal of a district of innovation shall not exceed five (5)

- 124 years and shall comply with administrative regulations promulgated
- 125 by the board pursuant to subsection (4) of this section.
- 126 (3) The board shall promulgate administrative rules and
- 127 regulations to prescribe the conditions and procedures to be used
- 128 by a local school board to be approved as a district of innovation
- 129 and shall publish the same on or before December 31, 2015.
- 130 (4) Administrative rules and regulations promulgated by the
- 131 board under subsection (3) of this section shall specify:
- 132 (a) The regulatory areas which may be exempted or
- 133 modified if approved by the board, except as provided in Section
- 134 37-179-3(2), and in addition to those areas identified in Section
- 135 37-179-3(3);
- 136 (b) The application, plan review, approval and
- 137 amendment process for a district;
- 138 (c) Timelines for initial approval as a district of
- 139 innovation, the renewal process and ongoing evaluative procedures
- 140 required of the district;
- 141 (d) Acceptable documentation of a critical mass of
- 142 parental, community, educator and business support and capacity to
- 143 effect a change;
- 144 (e) Evidence of teacher collaboration and shared
- 145 leadership within the district and the schools to be designated as
- 146 schools of innovation;
- 147 (f) The process of revocation of the designation of
- 148 district of innovation or school of innovation;

149	(g) Reporting and oversight responsibilities of the
150	district and the State Department of Education;
151	(h) The financial detail relating to budgets of schools
152	and evidence of sound fiscal management practices;
153	(i) Acceptable areas of emphasis for innovation;
154	(j) Acceptable documentation of job-embedded
155	professional development within the proposed innovation design;
156	and
157	(k) Other components deemed necessary to implement this
158	section and Section 37-179-3.
159	SECTION 2. Section 37-179-3, Mississippi Code of 1972, is
160	amended as follows:
161	37-179-3. (1) A district which is an applicant to be
162	designated as a district of innovation under Section 37-179-1
163	shall:
164	(a) Establish goals and performance targets for the
165	district of innovation proposal, which may include:
166	(i) Reducing socio-economic achievement gaps among
167	groups of public school students by expanding learning experiences
168	for students who are identified as academically low-achieving;
169	(ii) Increasing pupil learning through the
170	implementation of high, rigorous standards for pupil performance;
171	(iii) Increasing student attendance rates as well

172 as reducing chronic absenteeism;

173	(iv) Decreasing rates of student suspensions and
174	expulsions;
175	( * * $\star\underline{v}$ ) Increasing the participation of students
176	in various curriculum components and instructional components
177	within selected schools to enhance at each grade level;
178	( * * $\times \underline{vi}$ ) Increasing the number of students who
179	are college and career-ready and who have access to
180	dual-enrollment courses;
181	(vii) Increasing student college preparation to
182	enter secondary education in the areas of science, technology,
183	engineering and mathematics.
184	( * * $\times$ <u>viii</u> ) Motivating students at different
185	grade levels by offering more curriculum choices and student
186	learning opportunities to parents and students within the
187	district;
188	(b) Make public its goals and performance targets and,
189	after five (5) years, share the performance target results with
190	members of the Mississippi House and Senate Education Committees,
191	as well as with the general public;
192	( * * * <u>c</u> ) Identify changes needed <u>from a comprehensive</u>
193	needs and assets assessment in the district and schools to lead to
194	better prepared students for success in college, career and
195	life * * *;

- 208 (\* \* \*q) Document the fiscal and human resources the
- 209 board will provide throughout the term of the implementation of
- 210 the innovations within its plan; and
- 211 (\*\*\*h) Provide other materials as required by the
- 212 department in compliance with the board's administrative
- 213 regulations and application procedures.
- 214 (2) The district and all schools participating in a
- 215 district's innovation plan shall:
- 216 (a) Ensure the same health, safety, civil rights, and
- 217 disability rights requirements as are applied to all public
- 218 schools;
- 219 (b) Ensure students meet compulsory attendance
- 220 requirements under Sections 37-13-91 and 37-13-92;

- 229 Title 37, Mississippi Code of 1972;
- (e) Adhere to the same financial audits, audit
- 231 procedures, and audit requirements as are applied under Section
- 232 7-7-211(e);
- 233 (f) Require state and criminal background checks for
- 234 staff and volunteers as required of all public school employees
- 235 and volunteers within the public schools and specified in Section
- 236 37-9-17;
- 237 (q) Comply with open records and open meeting
- 238 requirements under Sections 25-41-1 et seq. and 25-61-1 et seq.;
- (h) Comply with purchasing requirements and limitations
- 240 under Chapter 39, Title 37, Mississippi Code of 1972;
- 241 (i) Provide overall instructional time that is
- 242 equivalent to or greater than that required under Sections 37-1-11
- 243 and 37-13-67, but which may include on-site instruction, distance
- 244 learning, online courses, and work-based learning on
- 245 nontraditional school days or hours; and

- 248 (3) (a) Only schools that choose to be designated as 249 schools of innovation shall be included in a district's 250 application;
- (b) As used in this paragraph, "eligible employees"

  means employees that are regularly employed at the school and

  those employees whose primary job duties will be affected by the

  plan; and
- (c) Notwithstanding the provisions of paragraph (a) of this subsection, a local school board may require a school that has been identified as a persistently low-achieving school under provisions of Section 37-17-6 to participate in the district's plan of innovation.
- 260 (4) Notwithstanding any statutes to the contrary, the board 261 may approve the requests of districts of innovation to:
- 262 (a) Use capital outlay funds for operational costs;
- (b) Hire persons for classified positions in

  nontraditional school and district assignments who have bachelors

  and advanced degrees from postsecondary education institutions

  accredited by a regional accrediting association (Southern

  Association of Colleges and Schools) or by an organization

  affiliated with the National Commission on Accrediting;

269	(c) Employ teachers on extended employment contracts or
270	extra duty contracts and compensate them on a salary schedule
271	other than the single salary schedule;
272	(d) Extend the school days as is appropriate within the
273	district with compensation for the employees as determined
274	locally;
275	(e) Establish alternative education programs and
276	services that are delivered in nontraditional hours and which may
277	be jointly provided in cooperation with another school district or
278	consortia of districts;
279	(f) Establish online classes within the district for
280	delivering alternative classes in a blended environment to meet
281	high school graduation requirements;
282	(g) Use a flexible school calendar;
283	(h) Convert existing schools into schools of
284	innovation; * * *
285	(i) Modify the formula under Section 37-151-7 for
286	distributing support education funds for students in average daily
287	attendance in nontraditional programming time, including
288	alternative programs and virtual programs. Funds granted to a
289	district shall not exceed those that would have otherwise been
290	distributed based on average daily attendance during regular
291	instructional days * * *; and
292	(j) Allow community schools to seek and accept gifts,

grants, donations, and funds from federal and state agencies,

295 related to its function as a community school.

296 **SECTION 3.** This act shall take effect and be in force from

297 and after July 1, 2021.
