HOUSE BILL NO. 511 (As Sent to Governor)

- AN ACT TO AMEND SECTION 45-49-3, MISSISSIPPI CODE OF 1972, TO CHANGE THE PERIOD FOR ISSUANCE OF AN AMUSEMENT RIDE OPERATING PERMIT DECAL FROM 12 MONTHS TO A CALENDAR YEAR; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 45-49-3, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 45-49-3. (1) An amusement ride may not be operated in this
- 9 state unless the Mississippi Department of Revenue has issued an
- 10 operating permit decal for the amusement ride to the owner or
- 11 operator * * * for the current calendar year.
- 12 (2) An application for an operating permit decal must be
- 13 submitted to the department not fewer than fifteen (15) business
- 14 days before the first time the amusement ride is operated in the
- 15 state, and must include the following:
- 16 (a) Certificate of insurance in the amount of not less
- 17 than One Million Dollars (\$1,000,000.00) per occurrence that
- 18 insures the owner or operator against liability for injury to

- 19 persons and property arising out of the use or operation of the
- 20 amusement ride;
- 21 (b) Payment of a fee not to exceed One Hundred Dollars
- 22 (\$100.00); and
- 23 (c) Proof of satisfactory inspection of the ride by a
- 24 qualified inspector, as defined in Section 45-49-5, conducted no
- 25 earlier than fifteen (15) days before the submission of the
- 26 application for an operating permit decal. The date of the
- 27 inspection must be indicated on the proof of inspection.
- 28 (3) The operating permit decal shall be valid * * * until
- 29 the end of the calendar year of the date of issue and must be in a
- 30 manner and format as prescribed by the department.
- 31 (4) The operating permit decal must be affixed to the ride
- 32 in a conspicuous location that is plainly visible to patrons.
- 33 (5) The department shall:
- 34 (a) Determine the manner and format of the operating
- 35 permit decal, any forms to be used to apply for the decal, and any
- 36 forms to be used to report serious injuries or illnesses;
- 37 (b) Make any forms and certifications available on the
- 38 department's website and provide decals to owners or operators;
- 39 (c) Subject to the limitations of this act, determine
- 40 the fee for the filing of an operating permit decal;
- 41 (d) Allow an owner or operator to apply for operating
- 42 permit decals for multiple rides at one time, using one (1) form;

- 45 application form, regardless of the number of rides listed on the
- 46 application.
- 47 **SECTION 2.** This act shall take effect and be in force from
- 48 and after its passage.
