1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE 2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF SPECIAL FUNDS 3 PREVIOUSLY APPROPRIATED FOR CONSTRUCTION AND/OR REPAIR AND 4 RENOVATION PROJECTS AT VARIOUS STATE AGENCIES AND INSTITUTIONS, 5 FOR FISCAL YEAR 2022.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 7 SECTION 1. The following sum, or so much thereof as may be necessary, is reappropriated out of any money in the State 8 Treasury to the credit of Fund No. 3393100000 to the Department of 9 10 Finance and Administration, acting through the Bureau of Building, 11 Grounds and Real Property Management, for the purpose of 12 reauthorizing the expenditure of funds previously appropriated for construction and/or repair and renovation projects at various 13 state agencies and institutions, as authorized in House Bill No. 14 15 1705, 2020 Regular Session, for the fiscal year beginning July 1, 2021, and ending June 30, 2022..... \$ 62,940,672.00. 16 This reappropriation is made for the purpose of reauthorizing 17 the expenditure of special funds for construction and/or repair 18

19 and renovation projects at various state agencies and institutions 20 that had been authorized by the Legislature in prior fiscal years.

Notwithstanding the amount reappropriated under the provisions of this section, in no event shall the amount expended exceed the unexpended balance as of June 30, 2021, or change the purpose for which the funds were originally authorized.

SECTION 2. The following sum, or so much thereof as may be 25 26 necessary, is reappropriated out of any money in any special fund 27 in the State Treasury to the credit of Fund 3390200000 to the Department of Finance and Administration, acting through the 28 29 Bureau of Building, Grounds and Real Property Management, as authorized in HB 1705, 2020 Regular Session; HB 1666, 2019 Regular 30 31 Session; HB 1616, 2018 Regular Session; SB 3015, 2017 Regular 32 Session; SB 2911, 2016 Regular Session; SB 2902, 2014 Regular Session; and SB 2896, 2013 Regular Session, for the fiscal year 33 34 beginning July 1, 2021, and ending June 30, 2022.....\$ 1,739,055.00. 35

The following sum, or so much thereof as may be 82 necessary, is reappropriated out of any money in any special fund 83 in the State Treasury to the credit of Fund 6493200000 to the 84 Department of Finance and Administration, acting through the Bureau of Building, Grounds and Real Property Management, as 85 86 authorized in HB 1705, 2020 Regular Session; and House Bill 1667, 87 2019 Regular Session for the fiscal year beginning July 1, 2021, 88 and ending June 30, 2022\$ 207,965.00. 89 This reappropriation is made for the purpose of reauthorizing 90 the expenditure of Capital Expense Funds previously appropriated by the Legislature in the prior fiscal year for improvements for 91 92 the Law Enforcement Officer's Training Academy.

93 Notwithstanding the amount reappropriated under the 94 provisions of this section, in no event shall the amount expended 95 exceed the unexpended balance as of June 30, 2021, or change the 96 purpose of which the funds were originally authorized.

SECTION 6. The following sum, or so much thereof as may be 97 98 necessary, is reappropriated out of any money in the State 99 Treasury to the credit of Fund No. 6493300000 to the Department of Finance and Administration, acting through the Bureau of Building, 100 101 Grounds and Real Property Management, as authorized in HB 1705, 102 2020 Regular Session; and Senate Bill 3049, 2019 Regular Session for the fiscal year beginning July 1, 2021, and ending June 30, 103 104 2022\$ 3,801,654.00.

105 This reappropriation is made for the purpose of reauthorizing 106 the expenditure of Capital Expense funds for construction and/or 107 repair, renovation, and improvements of state-owned properties, 108 universities and community colleges that had been authorized by 109 the Legislature in a prior fiscal year.

Notwithstanding the amount reappropriated under the provisions of this section, in no event shall the amount expended exceed the unexpended balance as of June 30, 2021, or change the purpose of which the funds were originally authorized.

SECTION 7. The Bureau of Building, Grounds and Real Property Management of the Office of General Services is expressly authorized and empowered to receive, budget and expend any state,

117 local or other source funds designated for supplemental funding of 118 construction and/or repair and renovation projects.

119 SECTION 8. The money herein appropriated shall be paid by 120 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 121 warrants issued by the State Fiscal Officer; and the State Fiscal 122 123 Officer shall issue his warrants upon requisitions signed by the 124 proper person, officer or officers, in the manner provided by law. 125 SECTION 9. This act shall take effect and be in force from 126 and after July 1, 2021.
