- 28 light on the legacy of Mississippi's own Jim Henson, whose beloved
- 29 Muppets help fill the world with joy, laughter, compassion and a

- 32 the future of Mississippi by growing their business in Starkville
- 33 and contributing to downtown revitalization and the community's
