- 4 PURPOSE OF POSSIBLE AMENDMENT; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 37-19-10, Mississippi Code of 1972, is
- 7 brought forward as follows:
- 8 37-19-10. (1) The Legislature finds that there is a need
- 9 for a performance incentive program for outstanding teachers and
- 10 staff in highly productive schools.
- 11 (2) Beginning with the 2016-2017 school year, the School
- 12 Recognition Program is created to provide financial awards to
- 13 public schools that:
- 14 (a) Sustain high performance by earning a school
- 15 accountability rating of "A" which shall be funded at One Hundred
- 16 Dollars (\$100.00) per pupil in average daily attendance;
- 17 (b) Sustain high performance by earning a school
- 18 accountability rating of "B" which shall be funded at Seventy-five
- 19 Dollars (\$75.00) per pupil in average daily attendance; or

- 20 (c) Demonstrate exemplary performance by improving at
- 21 least one (1) letter grade, which shall be funded at One Hundred
- 22 Dollars (\$100.00) per pupil in average daily attendance.
- 23 (3) All public schools, including charter schools, earning
- 24 the appropriate school rating are eligible to participate in the
- 25 program.
- 26 (4) School recognition awards must be used for nonrecurring
- 27 salary supplements to the teachers and staff employed in the
- 28 school receiving the financial award. Any nonrecurring salary
- 29 supplements paid to teachers and staff shall be prospective, shall
- 30 be paid over the remainder of the year, and shall not be
- 31 considered part of the local supplement. For contracted
- 32 individuals, there shall be an amendment to the existing contract.
- 33 (5) School recognition awards shall not be used for
- 34 administrators.
- 35 (6) There is hereby created in the State Treasury, the
- 36 School Recognition Program Fund which shall be used by the State
- 37 Department of Education, depending on the availability of funds as
- 38 appropriated, to provide financial awards to schools under this
- 39 section. It shall be the duty of the State Department of
- 40 Education to file with the State Treasurer and the State Fiscal
- 41 Officer such data and information as may be required to enable the
- 42 said State Treasurer and State Fiscal Officer to distribute the
- 43 School Recognition Program Funds by electronic funds transfer to
- 44 the several school districts at the time required and provided

45 under the provisions of this section. Such data and information 46 so filed shall show in detail the amount of funds to which each school district is entitled from the School Recognition Program 47 Such data and information so filed may be revised from time 48 49 to time as necessitated by law. At the time provided by law, the 50 State Treasurer and the State Fiscal Officer shall distribute to the several school districts the amounts to which they are 51 52 entitled from the School Recognition Program Fund as provided by 53 this section. Such distribution shall be made by electronic funds 54 transfer to the depositories of the several school districts 55 designated in writing to the State Treasurer based upon the data 56 and information supplied by the State Department of Education for 57 such distribution. In such instances, the State Treasurer shall 58 submit a request for an electronic funds transfer to the State 59 Fiscal Officer, which shall set forth the purpose, amount and 60 payees, and shall be in such form as may be approved by the State 61 Fiscal Officer so as to provide the necessary information as would be required for a requisition and issuance of a warrant. A copy 62 63 of the record of said electronic funds transfers shall be 64 transmitted by the school district depositories to the Treasurer, 65 who shall file duplicates with the State Fiscal Officer. 66 Treasurer and State Fiscal Officer shall jointly promulgate regulations for the utilization of electronic funds transfers to 67 68 school districts from the School Recognition Program Fund.
