COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 2149

AN ACT TO AMEND SECTION 37-151-103, MISSISSIPPI CODE OF 1972, 2 TO REQUIRE THE STATE DEPARTMENT OF EDUCATION TO HOLD SCHOOL DISTRICTS HARMLESS WHEN CALCULATING AVERAGE DAILY ATTENDANCE FOR 4 THE 2020-2021 SCHOLASTIC YEAR; TO PROVIDE THAT THE STATE 5 DEPARTMENT OF EDUCATION SHALL USE EACH SCHOOL DISTRICT'S AVERAGE 6 DAILY ATTENDANCE FOR THE 2019-2020 SCHOLASTIC YEAR IN PLACE OF THE 7 SCHOOL DISTRICT'S AVERAGE DAILY ATTENDANCE FOR THE 2020-2021 SCHOLASTIC YEAR IF IT IS GREATER THAN THE SCHOOL DISTRICT'S 8 9 AVERAGE DAILY ATTENDANCE FOR THE 2020-2021 SCHOLASTIC YEAR FOR THE 10 PURPOSE OF CALCULATING FUNDING UNDER THE MISSISSIPPI ADEQUATE 11 EDUCATION PROGRAM; AND FOR RELATED PURPOSES. 12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 13 SECTION 1. Section 37-151-103, Mississippi Code of 1972, is amended as follows: 14

- 15 37-151-103. (1) Funds due each school district and charter
- 16 school under the terms of this chapter from the Adequate Education
- 17 Program Fund shall be paid in the following manner: Two (2)
- 18 business days prior to the last working day of each month there
- 19 shall be paid to each school district and charter school, by
- 20 electronic funds transfer, one-twelfth (1/12) of the funds to
- 21 which the district or charter school is entitled from funds
- 22 appropriated for the Adequate Education Program Fund. However, in

- 23 December those payments shall be made on December 15th or the next
- 24 business day after that date. All school districts shall process
- 25 a single monthly payroll for licensed employees and may process a
- 26 single monthly or a semimonthly payroll for nonlicensed employees,
- 27 in the discretion of the local school board, with electronic
- 28 settlement of payroll checks secured through direct deposit of net
- 29 pay for all school district employees. In addition, the State
- 30 Department of Education may pay school districts and charter
- 31 schools from the common school fund and the Adequate Education
- 32 Program Fund on a date earlier than provided for by this section
- 33 if it is determined that it is in the best interest of school
- 34 districts and charter schools to do so.
- 35 Provided, however, that if the cash balance in the State
- 36 General Fund is not adequate on the due date to pay the amounts
- 37 due to all school districts and charter schools in the state as
- 38 determined by the State Superintendent of Education, the State
- 39 Fiscal Officer shall not transfer said funds payable to any school
- 40 district or districts or charter schools until money is available
- 41 to pay the amount due to all districts and charter schools.
- 42 (2) Notwithstanding any provision of this chapter or any
- 43 other law requiring the number of children in average daily
- 44 attendance or the average daily attendance of transported children
- 45 to be determined on the basis of the preceding year, the State
- 46 Board of Education is hereby authorized and empowered to make
- 47 proper adjustments in allotments in cases where major changes in

- 48 the number of children in average daily attendance or the average 49 daily attendance of transported children occurs from one year to 50 another as a result of changes or alterations in the boundaries of school districts, the sending of children from one county or 51 52 district to another upon a contract basis, the termination or 53 discontinuance of a contract for the sending of children from one 54 county or district to another, a change in or relocation of 55 attendance centers, or for any other reason which would result in 56 a major decrease or increase in the number of children in average 57 daily attendance or the average daily attendance of transported 58 children during the current school year as compared with the 59 preceding year.
- 60 In the event of an inordinately large number of absentees in any school district or charter school as a result of 61 62 epidemic, natural disaster, or any concerted activity discouraging 63 school attendance, then in such event school attendance for the 64 purposes of determining average daily attendance under the adequate education program shall be based upon the average daily 65 66 attendance for the preceding school year for such school district 67 or charter school.
- 68 (4) The State Department of Education shall hold school
 69 districts harmless for each school district's average daily
 70 attendance calculation for the 2020-2021 scholastic year. For
 71 purposes of determining average daily attendance for the 2020-2021
 72 scholastic year, the State Department of Education shall use each

- 73 school district's average daily attendance for the 2019-2020
- 74 scholastic year if it is greater than the school's average daily
- 75 attendance for the 2020-2021 scholastic year.
- 76 **SECTION 2.** This act shall take effect and be in force from
- 77 and after July 1, 2021.
