SENATE BILL NO. 2305 (As Passed the Senate)

AN ACT TO CODIFY NEW SECTION 37-106-36, MISSISSIPPI CODE OF 1972, TO CREATE THE "WILLIAM F. WINTER AND JACK REED, SR., TEACHER LOAN REPAYMENT PROGRAM" TO BE ADMINISTERED BY THE STATE FINANCIAL AID BOARD; TO PROVIDE FOR THE QUALIFICATIONS FOR APPLICANTS UNDER 5 THE LOAN PROGRAM; TO ESTABLISH THE WILLIAM F. WINTER AND JACK REED, SR., LOAN REPAYMENT PROGRAM FUND; TO REPEAL SECTION 7 37-106-35, MISSISSIPPI CODE OF 1972, WHICH CREATES THE ASSISTANT 8 TEACHER FORGIVABLE LOAN PROGRAM; TO REPEAL SECTION 37-106-37, MISSISSIPPI CODE OF 1972, WHICH CREATES THE TEACHER EDUCATION 9 SCHOLARS FORGIVABLE LOAN PROGRAM; TO REPEAL SECTION 37-106-57, 10 MISSISSIPPI CODE OF 1972, WHICH CREATES THE WILLIAM F. WINTER 11 12 TEACHER FORGIVABLE LOAN PROGRAM; TO REPEAL SECTION 37-106-77, MISSISSIPPI CODE OF 1972, WHICH CREATES THE MISSISSIPPI TEACHING 13 FELLOWS FORGIVABLE LOAN PROGRAM; TO REPEAL SECTION 37-106-79, 14 MISSISSIPPI CODE OF 1972, WHICH CREATES THE TEACHER EDUCATION 15 16 ALTERNATE ROUTE CERTIFICATION SCHOLARS PROGRAM; AND FOR RELATED 17 PURPOSES. 18 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

- 19 SECTION 1. The following shall be codified as Section
- 20 37-106-36, Mississippi Code of 1972:
- 21 37-106-36. (1) There is established the "William F. Winter
- 22 and Jack Reed, Sr., Teacher Loan Repayment Program."
- 23 Subject to the availability of funds, an eligible
- 24 applicant for an initial award must have:

- 26 institution of higher learning which is regionally accredited by
- 27 the Southern Association of Colleges and Schools (SACS) or a
- 28 comparable accreditation body;
- 29 (b) Signed a contract as a full-time first-year teacher
- 30 in a public school district in Mississippi;
- 31 (c) Obtained a standard five-year license. Persons
- 32 with emergency licenses shall not be eligible applicants; and
- 33 (d) Outstanding qualifying undergraduate educational
- 34 loans, which may include the principal, interest and related
- 35 expenses such as the required interest premium on the unpaid
- 36 balances of government and commercial loans obtained by the
- 37 recipient for undergraduate educational expense.
- 38 (3) Persons who have received funds from other forgivable
- 39 loan programs established for teachers under Mississippi law, or
- 40 who are presently in default or delinquent on any federal, state,
- 41 local or commercial qualifying educational loan, shall not be
- 42 eligible for this program.
- 43 (4) Initial recipients shall be selected on a first-come,
- 44 first-served basis of all eligible applicants. Priority
- 45 consideration shall first be given to renewal applicants.
- 46 (5) Among first-time, first-year teacher recipients,
- 47 priority consideration shall be given to persons who are teaching
- 48 in a public school district designated as a geographical critical
- 49 teacher shortage area by the State Board of Education.

- 50 (6) Awards for recipients who have signed a contract to
- 51 teach in a public school district that is not designated as a
- 52 geographical critical teacher shortage area shall be as follows:
- 53 (a) Two Thousand Five Hundred Dollars (\$2,500.00) for
- 54 the first year of teaching;
- 55 (b) Three Thousand Five Hundred Dollars (\$3,500.00) for
- 56 the second year of teaching; and
- 57 (c) Four Thousand Five Hundred Dollars (\$4,500.00) for
- 58 the third year of teaching.
- 59 (7) Awards for recipients who have signed a contract to
- 60 teach in a public school district that is designated as a
- 61 geographical critical teacher shortage area shall be as follows:
- 62 (a) Four Thousand Five Hundred Dollars (\$4,500.00) for
- 63 the first year of teaching;
- (b) Five Thousand Five Hundred Dollars (\$5,500.00) for
- 65 the second year of teaching, provided the recipient continues to
- 66 teach in the same public school district or another public school
- 67 district designated a geographical shortage area by the State
- 68 Board of Education; and
- 69 (c) Six Thousand Five Hundred Dollars (\$6,500.00) for
- 70 the third year of teaching, provided the recipient continues to
- 71 teach in the same public school district or another public school
- 72 district designated a geographical shortage area by the State
- 73 Board of Education.

- 74 (8) A first-year recipient who moves to another public 75 school district shall be eligible to receive an award based on the 76 amount allowed under the program in the new district where the 77 teacher is employed.
- 78 (9) Awards shall be granted on a year-to-year basis, and 79 recipients shall have no obligation to seek a future award.
- (10) Awards shall be paid annually, after the expiration of
 the one-year teaching contract for which the award was granted, to
 the recipient's lender or loan service provider, and shall be
 applied to the outstanding balance. Monies paid on the
 recipient's behalf toward qualifying undergraduate educational
 loans prior to receiving payment of the award shall not be
 eligible for repayment through the program.
- 87 (11) During the teaching year for which the award is 88 granted, a recipient must at all times keep the State Financial 89 Aid Board informed of any changes to the recipient's current 90 contact information and employment status.
- 91 (12) Recipients who fail to maintain a standard license or 92 fail to fulfill the one-year teaching contract on which the award 93 was based shall forfeit any right to the award.
- 94 (13) The State Financial Aid Board, in collaboration with 95 the State Board of Education, shall track recipients of an award 96 under this program through their fifth teaching year, unless the 97 recipient shall leave teaching in a public school district at an 98 earlier date. Data collected shall include recipients'

- 99 undergraduate institution, school district, subject area/grade
- 100 level in teaching and any other pertinent information necessary to
- 101 determine the efficacy of the program in retaining teachers in
- 102 their first three (3) years of teaching.
- 103 (14) The State Financial Aid Board shall promulgate
- 104 regulations necessary for the proper administration of this
- 105 section.
- 106 (15) There is established in the State Treasury a special
- 107 fund to be designated the "William F. Winter and Jack Reed, Sr.,
- 108 Loan Repayment Program Fund," into which shall be deposited those
- 109 funds appropriated by the Legislature, and any other funds that
- 110 may be made available, for the purpose of implementing the loan
- 111 repayment program established herein. Money in the fund at the
- 112 end of the fiscal year shall not lapse into the General Fund, and
- interest earned on any amounts deposited into the fund shall be
- 114 credited to the special fund.
- 115 **SECTION 2.** Section 37-106-35, Mississippi Code of 1972,
- 116 which creates the Assistant Teacher Forgivable Loan Program, is
- 117 repealed.
- 118 **SECTION 3.** Section 37-106-37, Mississippi Code of 1972,
- 119 which creates the Teacher Education Scholars Forgivable Loan
- 120 Program, is repealed.
- 121 **SECTION 4.** Section 37-106-57, Mississippi Code of 1972,
- 122 which creates the William F. Winter Teacher Forgivable Loan
- 123 Program, is repealed.

- 131 and after July 1, 2021, and shall stand repealed on June 30, 2021.
