- AN ACT TO AMEND SECTION 9, CHAPTER 450, LAWS OF 2020, TO 2 REVISE THE DESIGNATION OF A SEGMENT OF MISSISSIPPI HIGHWAY 42 IN GREENE COUNTY, MISSISSIPPI, AS THE "DEPUTY U.S. MARSHAL JAKE GREEN 3 AND GREENE COUNTY DEPUTY LAWRENCE DUNNAM MEMORIAL HIGHWAY, EOW 5 APRIL 1, 1921"; TO DESIGNATE A SEGMENT OF MISSISSIPPI HIGHWAY 389 6 IN CHICKASAW COUNTY, MISSISSIPPI, AS THE "JIMMY PORTER MEMORIAL HIGHWAY"; TO DESIGNATE A SEGMENT OF U.S. HIGHWAY 49 IN HATTIESBURG, FORREST COUNTY, MISSISSIPPI, AS THE "CLYDE KENNARD 7 8 MEMORIAL HIGHWAY"; TO DESIGNATE A SEGMENT OF MISSISSIPPI HIGHWAY 9 489 IN NEWTON COUNTY, MISSISSIPPI, AS THE "JASON BOYD MEMORIAL HIGHWAY"; TO DESIGNATE A SEGMENT OF U.S. HIGHWAY 82 IN LEFLORE 10 11 12 COUNTY, MISSISSIPPI, AS THE "DEPUTY MELVIN P. 'BUSTER' BROWN, JR., MEMORIAL HIGHWAY"; AND FOR RELATED PURPOSES. 13 14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. Section 9, Chapter 450, Laws of 2020, is amended 15

- Section 9. (1) The segment of Mississippi Highway 42 in 17
- Greene County, Mississippi, beginning at its southern intersection 18
- 19 with Mississippi Highway 63 and extending one (1) mile west, is
- designated as the " * * *Deputy U.S. Marshal Jake Green and Greene 20
- 21 County Deputy Lawrence Dunnam Memorial Highway, EOW April 1,
- 22 1921."

- SECTION 2. (1) The segment of Mississippi Highway 389 in

- 29 the "Jimmy Porter Memorial Highway."
- 30 (2) The Mississippi Department of Transportation shall erect
- 31 and maintain appropriate signs along and approaching the segment
- 32 of highway described in subsection (1) of this section.
- 33 <u>SECTION 3.</u> (1) The segment of U.S. Highway 49 in Forrest
- 34 County beginning at its intersection with Hardy Street in
- 35 Hattiesburg and extending one (1) mile north is designated as the
- 36 "Clyde Kennard Memorial Highway."
- 37 (2) The Mississippi Department of Transportation shall erect
- 38 and maintain appropriate signs along and approaching the segment
- 39 of highway described in subsection (1) of this section.
- 40 **SECTION 4.** (1) The segment of Mississippi Highway 489 in
- 41 Newton County, Mississippi, beginning at its intersection with
- 42 Mills Road and extending one (1) mile north, is designated as the
- 43 "Jason Boyd Memorial Highway."
- 44 (2) The Mississippi Department of Transportation shall erect
- 45 and maintain appropriate signs along and approaching the segment
- 46 of highway described in subsection (1) of this section.

47	SECTION 5. (1) The segment of U.S. Highway 82 in Leflore
48	County, Mississippi, beginning at the western city limits of the
49	City of Greenwood and extending one (1) mile west, is designated
50	as the "Deputy Melvin P. 'Buster' Brown, Jr., Memorial Highway."
51	(2) The Mississippi Department of Transportation shall erect
52	and maintain appropriate signs along and approaching the segment
53	of highway described in subsection (1) of this section.
54	SECTION $\underline{\underline{6}}$. This act shall take effect and be in force from
55	and after <u>its passage</u> .
