SENATE BILL NO. 2485

AN ACT TO AUTHORIZE THE ISSUANCE STATEWIDE OF A PERMIT FOR
HUNTING WITH DOGS, TO BE PATTERNED AFTER THE PERMIT AUTHORIZED IN
HOMOCHITTO NATIONAL FOREST UNDER THE REGULATIONS OF THE
MISSISSIPPI DEPARTMENT OF WILDLIFE, FISHERIES AND PARKS; AND FOR

5 RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** The permit for hunting with dogs in Homochitto
- 8 National Forest shall be authorized statewide under the same terms
- 9 and conditions, except geographic limitations, applying to the
- 10 permit under Title 40, Part 2, Chapter 1, Rule 2.2F of the
- 11 Mississippi Administrative Code on January 1, 2021, as follows:
- 12 (a) From November 1 to January 31, all dog hunting
- 13 groups or individuals hunting with dogs must obtain a permit to
- 14 use dogs to hunt any animal or to train dogs on areas open to deer
- 15 hunting with dogs in the State of Mississippi.
- 16 (b) There is no cost for this permit. A permit will be
- 17 issued to the dog hunting group.

- 19 on the permit prior to hunting, except youth fifteen (15) years of
- 20 age and younger.
- 21 (d) All hunters hunting with dogs or with the dog
- 22 hunting group must have the permit on their person while hunting.
- 23 (e) Five (5) quest permits will be available in
- 24 addition to the individuals listed on the permit. A guest permit
- 25 will be valid for four (4) consecutive days and must be filled out
- 26 with the date, the hunter's name and hunting license number, and
- 27 the guest permit must be signed by the hunter prior to use.
- 28 (f) All quests must have the permit on their person
- 29 while hunting.
- 30 (q) Guest permits must be turned in to the department
- 31 for replacement quest permits to be issued. When quest permits
- 32 are turned in, a season permit will be issued for these
- 33 individuals, and replacement guest permits will be issued to the
- 34 group.
- 35 (h) Permit numbers must be visually displayed on the
- 36 back window of all vehicles in the hunting group.
- 37 (i) A permit number will be provided with each
- 38 individual permit issued. Hunters must display this permit number
- 39 using three-inch, block numbers in contrast to the background
- 40 color.
- 41 (j) Permits will be available from the department
- 42 office.

43	(k) Dogs must wear a functional tracking collar and be
44	identified at all times with the permit number and the owner's
45	contact information. Dogs must be kept on the lands that allow
46	deer hunting with dogs.

- 47 A person who violates any provision of this section 48 is quilty of a Class III offense, as provided in Section 49-7-101, and, upon conviction, shall be fined not less than Twenty-Five 49 Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00). 50
- An administrative review panel of department officials may, upon two (2) convictions for violations of this section, or upon documented evidence of two (2) violations of this 53 section, within a three-year period, revoke the dog hunting permit for a period of twenty (20) days. Upon three (3) convictions for 55 violations of this section, or upon documented evidence of three 57 (3) violations of this section, within a three-year period, the 58 dog hunting permit may be revoked for a period of one (1) year.
 - Any person who files a false affidavit alleging a (n) violation or violations of this section, provides false information regarding a violation of this section, or facilitates a situation which will cause a violation of this section may be subject to prosecution for perjury and, if found quilty, punished under the provisions of Section 97-9-19, and/or subject to a civil suit for false prosecution by the person accused of the violation.
- 66 SECTION 2. Section 1 of this act shall be codified in Title 49, Chapter 7, Mississippi Code of 1972. 67
