1 2 3 4	A CONCURRENT RESOLUTION EXPRESSING THE INTENT OF THE MISSISSIPPI LEGISLATURE THAT DAYLIGHT SAVING TIME SHALL BE THE YEAR-ROUND STANDARD TIME OF THE ENTIRE STATE OF MISSISSIPPI AND ITS POLITICAL SUBDIVISIONS.
5	WHEREAS, when Congress enacted The Emergency Daylight Saving
6	Time Energy Conservation Act of 1973, it included in its findings
7	and declarations of policy that "various studies of governmental
8	and nongovernmental agencies indicate that year-round daylight
9	saving time would produce an energy saving in electrical power
10	consumption"; and
11	WHEREAS, Congress also found and declared that "the use of
12	year-round daylight saving time could have other beneficial
13	effects on the public interest, including the reduction of crime,
14	improved traffic safety, more daylight outdoor playtime for
15	children and youth of our nation, [and] greater utilization of
16	parks and recreation areas"; and
17	WHEREAS, Congress further found and declared that the use of
18	year-round daylight saving time could result in "expanded economic
19	opportunity through extension of daylight hours to peak shopping

- 20 hours and through extension of domestic office hours to periods of
- 21 greater overlap with the European Economic Community"; and
- 22 WHEREAS, the principles listed above are still applicable to
- 23 this day, and by allowing the individual states the choice to
- 24 establish daylight saving time as the standard time, today's
- 25 Congress will allow such states to enjoy the benefits that
- 26 Congress found so compelling as to enshrine in law; NOW,
