House Amendments to Senate Bill No. 2909

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

PAGE 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5 SECTION 1. The following sum, or so much thereof as may be 6 necessary, is hereby appropriated out of any money in the State 7 General Fund not otherwise appropriated, to the Board of Trustees 8 of State Institutions of Higher Learning for the purpose of paying 9 the expenses incurred in the operation and maintenance of the Forest and Wildlife Research Center, for the fiscal year beginning 10 July 1, 2021, and ending June 30, 2022.....\$ 11 5,245,065.00. 12 SECTION 2. The following sum, or so much thereof as may be necessary, is hereby authorized for expenditure out of any special 13 14 source funds which are collected by or otherwise become available 15 for the purpose of defraying the expenses of the Forest and 16 Wildlife Research Center, for the fiscal year beginning 17 July 1, 2021, and ending June 30, 2022.....\$ 1,164,064.00. SECTION 3. No general funds authorized to be expended herein 18 19 shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions 20 21 of this act and which are withdrawn and no longer available. S. B. 2909

- 22 **SECTION 4.** It is the intention of the Legislature that if
- 23 the funds appropriated in Section 1 of this act are used directly
- 24 or indirectly to match or otherwise secure any federal grants,
- 25 research grants or donations, such special source funds not
- 26 classified as restricted funds shall be added and accounted for
- 27 under Section 2 of this act. Further, it is the intention of the
- 28 Legislature that all such aforementioned special source funds be
- 29 included in all reports and requests for the 2022 Regular Session
- 30 of the Mississippi Legislature.
- 31 **SECTION 5.** It is the intention of the Legislature that the
- 32 agency's budget request for Fiscal Year 2023 shall be submitted to
- 33 the Joint Legislative Budget Committee in a format and level of
- 34 detail comparable to the format and level of detail provided
- 35 during the Fiscal Year 2022 budget request process.
- 36 **SECTION 6.** Of the funds appropriated in Section 2, Two
- 37 Hundred Fifty-three Thousand Five Dollars (\$253,005.00) shall be
- 38 derived from the Education Enhancement Fund from funds deposited
- 39 pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of
- 40 1972.
- 41 **SECTION 7.** It is the intention of the Legislature that
- 42 whenever two (2) or more bids are received by this agency for the
- 43 purchase of commodities or equipment, and whenever all things
- 44 stated in such received bids are equal with respect to price,
- 45 quality and service, the Mississippi Industries for the Blind
- 46 shall be given preference. A similar preference shall be given to

- 47 the Mississippi Industries for the Blind whenever purchases are
- 48 made without competitive bids.
- It is the intention of the Legislature that the 49 SECTION 8.
- 50 funds herein appropriated shall be expended in compliance with
- 51 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 52 shall incur obligations or indebtedness in excess of their
- appropriation and that the responsible officers, either personally 53
- 54 or upon their official bonds, shall be held responsible for
- 55 actions contrary to this provision.
- 56 SECTION 9. The money herein appropriated shall be paid by
- 57 the State Treasurer out of any money in the State Treasury to the
- credit of the proper fund or funds as set forth in this act, upon 58
- 59 warrants issued by the State Fiscal Officer; and the State Fiscal
- Officer shall issue his warrants upon requisitions signed by the 60
- 61 proper person, officer or officers in the manner provided by law.
- 62 This act shall take effect and be in force from
- 63 and after July 1, 2021, and shall stand repealed from and after
- 64 June 29, 2021.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

1 AN ACT MAKING AN APPROPRIATION FOR THE PURPOSE OF DEFRAYING 2 THE EXPENSES INCURRED IN THE MAINTENANCE AND OPERATION OF THE FOREST AND WILDLIFE RESEARCH CENTER FOR FISCAL YEAR 2022.
