## House Amendments to Senate Bill No. 2941

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

## AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The	following sum of money, or	so much thereof as
6	may be necessary, is hereby appropriated out of any money in the		
7	State Treasury to the credit of the Mississippi State Board of		
8	Public Contractors, for the purpose of defraying the expenses of

11	SECTION 2. Of the funds appropriated under the provisions of

- Any transfers or escalations shall be made in accordance with
- 52 the terms, conditions and procedures established by law or

- 54 Personnel Board shall not escalate positions without written
- 55 approval from the Department of Finance and Administration. The
- 56 Department of Finance and Administration shall not provide written
- 57 approval to escalate any funds for salaries and/or positions
- 58 without proof of availability of new or additional funds above the
- 59 appropriated level.
- No general funds authorized to be expended herein shall be
- 61 used to replace federal funds and/or other special funds which are
- 62 being used for salaries authorized under the provisions of this
- 63 act and which are withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 65 violation of Internal Revenue Service's Publication 15-A relating
- 66 to the reporting of income paid to contract employees, as
- 67 interpreted by the Office of the State Auditor.
- 68 **SECTION 3.** Of the funds appropriated in this act, it is the
- 69 intention of the Legislature that the State Board of Contractors
- 70 may expend funds not to exceed Two Million Three Hundred Thousand
- 71 Dollars (\$2,300,000.00) for the purpose of defraying the cost of
- 72 (1) enforcement as set forth in Section 31-3-21, Mississippi Code
- 73 of 1972, (2) enlisting of any private collection firm(s) to locate

- 74 and collect any uncollected fines, and (3) administrative costs
- 75 associated with collections. Any funds spent for this purpose
- 76 shall be subject to a performance audit if requested by the
- 77 Appropriations Chairmen in either the House or Senate.
- 78 **SECTION 4.** It is the intention of the Legislature that
- 79 whenever two (2) or more bids are received by this agency for the
- 80 purchase of commodities or equipment, and whenever all things
- 81 stated in such received bids are equal with respect to price,
- 82 quality and service, the Mississippi Industries for the Blind
- 83 shall be given preference. A similar preference shall be given to
- 84 the Mississippi Industries for the Blind whenever purchases are
- 85 made without competitive bids.
- 86 **SECTION 5.** It is the intention of the Legislature that the
- 87 funds herein appropriated shall be expended in compliance with
- 88 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 89 shall incur obligations or indebtedness in excess of their
- 90 appropriation and that the responsible officers, either personally
- 91 or upon their official bonds, shall be held responsible for
- 92 actions contrary to this provision.
- 93 **SECTION 6.** The money herein appropriated shall be paid by
- 94 the State Treasurer out of any money in the State Treasury to the
- 95 credit of the proper fund or funds as set forth in this act, upon
- 96 warrants issued by the State Fiscal Officer; and the State Fiscal
- 97 Officer shall issue his warrants upon requisitions signed by the
- 98 proper person, officer or officers in the manner provided by law.

99 **SECTION 7.** This act shall take effect and be in force from 100 and after July 1, 2021.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE STATE TREASURY TO DEFRAY THE EXPENSES OF THE MISSISSIPPI STATE BOARD OF PUBLIC CONTRACTORS FOR FISCAL YEAR 2022.
