House Amendments to Senate Bill No. 2947

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum of money, or so much thereof as
6	may be necessary, is hereby appropriated out of any money in the
7	State Treasury to the credit of the State Department of Banking
8	and Consumer Finance, for the support of the State Department of
9	Banking and Consumer Finance, for the fiscal year beginning
10	July 1, 2021, and ending June 30, 2022\$ 11,668,589.00.
11	SECTION 2. Of the funds appropriated under the provisions of
12	this act, the following positions are authorized:

18	With the funds herein appropriated, it shall be the agency's
19	responsibility to make certain that funds required to be
20	appropriated for "Personal Services" for Fiscal Year 2023 do not
21	exceed Fiscal Year 2022 funds appropriated for that purpose unless

- Any transfers or escalations shall be made in accordance with

- 56 Department of Finance and Administration shall not provide written

- No general funds authorized to be expended herein shall be
- 61 used to replace federal funds and/or other special funds which are
- 62 being used for salaries authorized under the provisions of this
- 63 act and which are withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 65 violation of Internal Revenue Service's Publication 15-A relating
- 66 to the reporting of income paid to contract employees, as
- 67 interpreted by the Office of the State Auditor.
- 68 **SECTION 3.** It is the intention of the Legislature that the
- 69 Department of Banking and Consumer Finance shall maintain complete
- 70 accounting and personnel records related to the expenditure of all
- 71 funds appropriated under this act and that such records shall be
- 72 in the same format and level of detail as maintained for Fiscal
- 73 Year 2021. It is further the intention of the Legislature that

- 74 the agency's budget request for Fiscal Year 2023 shall be
- 75 submitted to the Joint Legislative Budget Committee in a format
- 76 and level of detail comparable to the format and level of detail
- 77 provided during the Fiscal Year 2022 budget request process.
- 78 **SECTION 4.** It is the intention of the Legislature that
- 79 whenever two (2) or more bids are received by this agency for the
- 80 purchase of commodities or equipment, and whenever all things
- 81 stated in such received bids are equal with respect to price,
- 82 quality and service, the Mississippi Industries for the Blind
- 83 shall be given preference. A similar preference shall be given to
- 84 the Mississippi Industries for the Blind whenever purchases are
- 85 made without competitive bids.
- 86 **SECTION 5.** It is the intention of the Legislature that the
- 87 funds herein appropriated shall be expended in compliance with
- 88 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 89 shall incur obligations or indebtedness in excess of their
- 90 appropriation and that the responsible officers, either personally
- 91 or upon their official bonds, shall be held responsible for
- 92 actions contrary to this provision.
- 93 **SECTION 6.** The money herein appropriated shall be paid by
- 94 the State Treasurer out of any money in the State Treasury to the
- 95 credit of the proper fund or funds as set forth in this act, upon
- 96 warrants issued by the State Fiscal Officer; and the State Fiscal
- 97 Officer shall issue his warrants upon requisitions signed by the
- 98 proper person, officer or officers in the manner provided by law.

99 **SECTION 7.** This act shall take effect and be in force from 100 and after July 1, 2021.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT MAKING AN APPROPRIATION OF SPECIAL FUNDS FOR THE SUPPORT OF THE STATE DEPARTMENT OF BANKING AND CONSUMER FINANCE FOR FISCAL YEAR 2022.
