

## House Amendments to Senate Concurrent Resolution No. 535

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

### AMENDMENT NO. 1

1           **AMEND** by inserting the following language after line 198:

2           "BE IT FURTHER RESOLVED BY THE SENATE OF THE STATE OF  
3 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That  
4 all of the deadlines and other provisions imposed by Joint Rule  
5 No. 40 are suspended for the purpose of the further consideration  
6 and passage of House Bill No. 1008, 2021 Regular Session, entitled  
7 "AN ACT TO AMEND SECTION 43-13-117, MISSISSIPPI CODE OF 1972, TO  
8 MAKE VARIOUS TECHNICAL AMENDMENTS AND REVISIONS TO THE MEDICAID  
9 SERVICES AND MANAGED CARE PROVISIONS; TO EXTEND THE DATE OF THE  
10 REPEALER ON THIS SECTION; TO AMEND SECTION 43-13-145, MISSISSIPPI  
11 CODE OF 1972, TO MAKE SEVERAL TECHNICAL AMENDMENTS AND REVISIONS  
12 TO THE MEDICAID ASSESSMENT PROVISIONS; TO DELETE THE DATE OF THE  
13 REPEALER ON THIS SECTION; TO AMEND SECTIONS 43-13-107 AND  
14 43-13-117.1, MISSISSIPPI CODE OF 1972, WHICH RELATE TO THE  
15 MEDICAID PROGRAM, TO MAKE SOME MINOR, NONSUBSTANTIVE CHANGES; TO  
16 BRING FORWARD SECTIONS 43-13-103, 43-13-105, 43-13-109, 43-13-113,  
17 43-13-116, 43-13-120, 43-13-121, 43-13-123, 43-13-125 AND  
18 43-13-139, MISSISSIPPI CODE OF 1972, WHICH RELATE TO THE MEDICAID

19 PROGRAM, FOR THE PURPOSES OF POSSIBLE AMENDMENT; AND FOR RELATED  
20 PURPOSES.""

21 **AMEND FURTHER** the title by inserting the following language  
22 after the semicolon on line 97: "AND SUSPENDING THE DEADLINES AND  
23 OTHER PROVISIONS OF JOINT RULE NO. 40 FOR THE PURPOSE OF THE  
24 FURTHER CONSIDERATION AND PASSAGE OF HOUSE BILL NO. 1008, 2021  
25 REGULAR SESSION, ENTITLED "AN ACT TO AMEND SECTION 43-13-117,  
26 MISSISSIPPI CODE OF 1972, TO MAKE VARIOUS TECHNICAL AMENDMENTS AND  
27 REVISIONS TO THE MEDICAID SERVICES AND MANAGED CARE PROVISIONS; TO  
28 EXTEND THE DATE OF THE REPEALER ON THIS SECTION; TO AMEND SECTION  
29 43-13-145, MISSISSIPPI CODE OF 1972, TO MAKE SEVERAL TECHNICAL  
30 AMENDMENTS AND REVISIONS TO THE MEDICAID ASSESSMENT PROVISIONS; TO  
31 DELETE THE DATE OF THE REPEALER ON THIS SECTION; TO AMEND SECTIONS

35 43-13-109, 43-13-113, 43-13-116, 43-13-120, 43-13-121, 43-13-123,  
36 43-13-125 AND 43-13-139, MISSISSIPPI CODE OF 1972, WHICH RELATE TO  
37 THE MEDICAID PROGRAM, FOR THE PURPOSES OF POSSIBLE AMENDMENT;""
