AMENDMENT NO 2 PROPOSED TO**

**House Bill No. 1013**

1       **AMEND** by inserting the following new paragraph (i) after line  
2 79:

3               "(i) Each member of the commission, before entering  
4 upon the discharge of the duties of the office, shall take and  
5 subscribe to the oath of office prescribed by the Mississippi  
6 Constitution and shall file the oath in the Office of the  
7 Secretary of State, and shall execute a bond in some surety  
8 company authorized to do business in the state in the penal sum of  
9 One Hundred Thousand Dollars (\$100,000.00), conditioned for the  
10 faithful and impartial discharge of the duties of the office. The  
11 bonds shall be filed in the Office of the Secretary of State, and  
12 the premium on the bonds shall be paid as provided by law out of  
13 funds appropriated to the commission."



14           **AMEND FURTHER** on line 110 by inserting the words "with the  
15 approval of the commission and" before the word "subject"

16           **AMEND FURTHER** on lines 176, 283, 287 and 288, 758, 786, 788,  
17 793, 794, 804 and 805, 864 and 865, 1048, 1068, 2179, 2197 by  
18 deleting the words "executive director" and inserting the word  
19 "commission"

20           **AMEND FURTHER** on lines 254 through 256 by deleting the words  
21 "the executive director, or his or her designee, shall present the  
22 commission's recommendation" and inserting the words "the  
23 commission shall present its recommendation"

24           **AMEND FURTHER** on lines 275 and 276 by deleting the words  
25 "executive director, or his or her designee" and inserting the  
26 word "commission"

27           **AMEND FURTHER** on line 289 by deleting the words "executive  
28 director's" and inserting the word "commission's"

29           **AMEND FURTHER** on line 725 and 726 by deleting the words  
30 "either by the executive director or his or her designee" and  
31 inserting the words "by the commission"

32           **AMEND FURTHER** on line 837 by inserting the following language  
33 after the word "director": ", with the approval of the commission



34 and subject to the rules and regulations of the State Personnel  
35 Board,"

36 **AMEND FURTHER** on lines 1128 and 1129 by deleting the  
37 following language: ", assisted by the commission,"

38 **AMEND FURTHER** on line 1378 by deleting the words "the  
39 executive director of"

40 **AMEND FURTHER** on lines 1465 and 1471 by deleting the word  
41 "subcommission" and inserting the word "subdivision"

42 **AMEND FURTHER** on line 1746 and 1747 by deleting the following  
43 language: ", after consultation with the executive director,"

44 **AMEND FURTHER** on line 2166 by deleting the words "other  
45 designated person or persons" and inserting the words "other  
46 person or persons designated by the commission"

47 **AMEND FURTHER** on line 2173 by deleting the words "executive  
48 director or other designated person" and inserting the word  
49 "commission"
