Amend by striking all after the enacting clause and inserting in lieu thereof the following:

4	SECTION 1. The following sum, or so much thereof as may be
5	necessary, is hereby appropriated out of any money in the State
6	General Fund not otherwise appropriated, for the purpose of
7	defraying the expenses and paying salaries of the Veterans Affairs
8	Board for the fiscal year beginning July 1, 2021, and ending
9	June 30, 2022 \$ 5,324,778.00
10	SECTION 2. The following sum, or so much thereof as may be
11	necessary, is hereby appropriated out of any money in the special
12	fund in the State Treasury to the credit of the Veterans Affairs
13	Board which is comprised of special source funds collected by or



L 4	otherwise available to the board, for the support and maintenance
L5	of said board for the fiscal year beginning July 1, 2021, and
L 6	ending June 30, 2022 \$ 44,112,274.00
L7	SECTION 3. Of the funds appropriated under the provisions of
L8	this act, the following positions are authorized:

20	Permanent: Full Time
21	Part Time 0
22	Time-Limited: Full Time 409

24	With the funds herein appropriated, it shall be the agency's
25	responsibility to make certain that funds required to be
26	appropriated for "Personal Services" for Fiscal Year 2023 do not
27	exceed Fiscal Year 2022 funds appropriated for that purpose unless
28	programs or positions are added to the agency's Fiscal Year 2022
29	budget by the Mississippi Legislature. Based on data provided by
30	the Legislative Budget Office, the State Personnel Board shall
31	determine and publish the projected annual cost to fully fund all
32	appropriated positions in compliance with the provisions of this
33	act. Absent a special situation or circumstance approved by the
34	State Personnel Board, or unless otherwise authorized by this act,
35	no state agency shall take any action to promote or otherwise
36	award salary increases through reallocation or realignment. If
37	the State Personnel Board determines a special situation or
38	circumstance exists and approves an action, then the agency and

- the State Personnel Board shall provide a monthly report of each action approved by the State Personnel Board to the chairmen of
- 41 the Accountability, Efficiency and Transparency Committees of the
- 42 Senate and House of Representatives and the chairmen of the
- 43 Appropriations Committees of the Senate and House of
- 44 Representatives. It shall be the responsibility of the agency
- 45 head to ensure that no single personnel action increases this
- 46 projected annual cost and/or the Fiscal Year 2022 appropriations
- 47 for "Personal Services" when annualized, with the exception of
- 48 escalated funds and the award of benchmarks. If, at the time the
- 49 agency takes any action to change "Personal Services," the State
- 50 Personnel Board determines that the agency has taken an action
- 51 which would cause the agency to exceed this projected annual cost
- 52 or the Fiscal Year 2022 "Personal Services" appropriated level,
- 53 when annualized, then only those actions which reduce the
- 54 projected annual cost and/or the appropriation requirement will be
- 55 processed by the State Personnel Board until such time as the
- 56 requirements of this provision are met.
- 57 Any transfers or escalations shall be made in accordance with
- 58 the terms, conditions and procedures established by law or
- 59 allowable under the terms set forth within this act. The State
- 60 Personnel Board shall not escalate positions without written
- 61 approval from the Department of Finance and Administration. The
- 62 Department of Finance and Administration shall not provide written
- 63 approval to escalate any funds for salaries and/or positions



- 64 without proof of availability of new or additional funds above the 65 appropriated level.
- No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this
- 69 act and which are withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 71 violation of Internal Revenue Service's Publication 15-A relating
- 72 to the reporting of income paid to contract employees, as
- 73 interpreted by the Office of the State Auditor.
- 74 **SECTION 4.** Of the funds appropriated under the provisions of
- 75 Sections 1 and 2, funds in the amount of Two Hundred Fifty
- 76 Thousand Dollars (\$250,000.00) are provided to defray the cost of
- 77 providing care to indigent/low-income Mississippi veterans and the
- 78 nonveteran surviving spouses of Mississippi veterans if the
- 79 surviving spouse was a resident of a state veterans home at the
- 80 time of the veteran's death and who, subsequent to the veteran's
- 81 death, meets the indigent/low-income criteria established by the
- 82 State Veterans Affairs Board, in the state veterans homes. It is
- 83 the intention of the Legislature that the provision pertaining to
- 84 use of indigent/low-income surviving spouses be retroactive for
- 85 any such period, prior to the effective date of this act, that a
- 86 current surviving spouse may have met the criteria. This section
- 87 and its provisions shall be known and cited as the "Hilton R.
- 88 'Jack' Vance Act of 1997."



- SECTION 5. The Veterans Affairs Board shall have continued authority for all action related to planning, development,
- 91 construction, and outfitting of the North Mississippi Veterans'
- 92 Memorial Cemetery.
- 93 **SECTION 6.** It is the intention of the Legislature that the
- 94 Veterans Affairs Board shall maintain complete accounting and
- 95 personnel records related to the expenditure of all funds
- 96 appropriated under the provisions of this act and that such
- 97 records shall be in the same format and level of details as
- 98 maintained for Fiscal Year 2021. It is further the intention of
- 99 the Legislature that the budget request for Fiscal Year 2023 shall
- 100 be submitted to the Joint Legislative Budget Committee in a format
- 101 and level of detail comparable to the format and level of detail
- 102 provided during the Fiscal Year 2022 budget request process.
- 103 **SECTION 7.** It is the intention of the Legislature that
- 104 whenever two (2) or more bids are received by this agency for the
- 105 purchase of commodities or equipment, and whenever all things
- 106 stated in such received bids are equal with respect to price,
- 107 quality and service, the Mississippi Industries for the Blind
- 108 shall be given preference. A similar preference shall be given to
- 109 the Mississippi Industries for the Blind whenever purchases are
- 110 made without competitive bids.
- 111 SECTION 8. The Veterans Affairs Board shall have the
- 112 authority to escalate and expend increased federal funds obtained
- 113 by virtue of Public Law 109-461 (38 CFR Part 51).



114	SECTION 9. The money herein appropriated shall be paid by
115	the State Treasurer out of any money in the State Treasury to the
116	credit of the proper fund or funds as set forth in this act, upon
117	warrants issued by the State Fiscal Officer; and the State Fiscal
118	Officer shall issue his warrants upon requisitions signed by the
119	proper person, officer or officers in the manner provided by law.
120	SECTION 10. This act shall take effect and be in force from
121	and after July 1, 2021, and shall stand repealed from and after
122	June 29, 2021.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT MAKING AN APPROPRIATION FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE VETERANS AFFAIRS BOARD FOR FISCAL YEAR 2022.
